This cause coming on to be heard upon the report of the Commissioners appointed to lay off and assess the site for a public school house lot as asked for in the petition and it appearing to the Court that J.H. Snow, S.C. Hamlin \& M.Y. Holyfield, Comrs appointed by the Court in the above entitled cause to lay off said lot, such on the premises of the above named defendant on the $12^{\text {th }}$ day of December 1911 and after being duly sworn by J.H. Poindexter, J.P., proceeded to lay off a site for a public school house for the white race, on the lands of Ruth Atkinson and John Atkinson, in Dobson Township \& bounded as follows: Beginning on a rock in W.M. Vernon's line on the west bank of the Dobson and Rockford road and runs with Vernon's line North 87 West 3 chains to a rock thence South 5 East $495 / 100$ chains to a rock; thence South 87 East $412 / 100$ chains to a rock on West Bank of said road; thence with the road as it now meanders; North 14 West 98 links; North 5 West 4 chains to the beginning, Containing $1 \frac{1}{2}$ acres.

It further appearing to the Court that said Comrs. assessed said lot on the price of $\$ 30.00$ and it is further appearing that said report was filed in this office on the $12^{\text {th }}$ day of December 1911, and that the price assessed on said lot is a fair and reasonable price for the same.
