

Found in a loose estate record for Phillip Howard in the North Carolina Archives in Raleigh, North Carolina. One must assume that the Clerk of Court was trying to conserve paper when found on one side of a large, folded piece of paper was written the dower's petition of Catherine Howard, wife of Phillip Howard, and on the other side was a petition of Sarah Eaton Stockton and husband William. This record has been placed on the problem shelf in the archives and they will see that the correct pages go into their own folders. Until then, this compiler thought some researchers might enjoy having the information.

That Sarah previous to their marriage of her and said William was the widow of Peter Eaton Dec'd who was at the time of his Death possesed of a large estate in lands, negroes, Bankstock and Debts owing to him Benjamin Eaten became his Executor exhibited an inventory that did not contain the full amount of said Dec'd Estate a bond for six hundred & fifty dollars with interest on Nathan Chaffen was left out of said inventory and in the first inventory return^d the bank stock was stated at five hundred Dollars where as said stock sold at the second sale which to place place after the returning the inventory for sum of seven hundred and fifty dollars with a Dividend of fifty more your petitioner Sary heretofore eachitectied? her petition to this court for Dower and her share of the personal estate ajury were accordingly appointed and laid off to her the land she was entitled to by law and such part of the personal estate as was then known to her to which she was entitled your petitioner state to your worshipe that the six hundred and fifty Dollar bond above mentioned and the three hundred and [the three hundred and written again and marked out] Dollars. The over? of the bank stock were not take into the account of the estate by the Jury being at that time unknown to them included in the inventory at that time filed by said Executor said Sarah although by Law entitled to a third of all the personal estate of her late Dec'd husband has been deprived of her share in the sum of upwards one thousand Dollars part of said estate they pray said may be summoned to answer this petition on oath and a Jury may be appointed agreeable to law to allott your petitioner her share in the ballance of the estate of said Eaten Dec'd since the allotment of the preceding Jury and you Petitioner &c.

Howard Family Surry - Onslow Counties North Carolina

It was written by a researcher some years ago......"It should be mentioned that in the office of the Register of Deeds in Jacksonville, the county-seat of Onslow Co., N. C. there is a pile of old papers some two feet high, which are leaves of old deed books, some of which have been transcribed into new books, but the majority of which are apparently untouched. The same condition is found in the Clerk's office, where there is as large a pile of old court records. It would take two or three weeks to go through these old papers, but it is probable that a thorough examination of these would give most valuable information.......".

This researcher does not know the fate of these records today but one can only hope that they have been lovingly taken care of by now. The foregoing paragraph was given to the Archivist in Raleigh, N. C. in hopes that they can either get these records for safe keeping, or make sure, they have been taken care of; if not lost by now.

One of the loose deeds found in the floor......

Sept. 3, 1814 "Joseph Howard in his own right and Joseph Howard as agent & Attorney to his brother Jesse Howard both of the County of Surry, N. C. to Lemuel Dety of Onslow Co. Consideration £125?. 4 tracts of land; 640 acres granted to Richard Farr, March 4. 1776; 200 acres granted to Edward Howard, November 10, 1784; 200 acres granted to Edward Howard November 9, 1784; 30/50? acres granted to Edward Howard May 16, 1787; "With all the Rights, title & Interest I may have or my said brother Jesse Howard may have in the County of Onslow and State aforesaid as heirs to our deceased father Edward Howard or Stephen Howard & James Howard my deceased brothers.

No will or estate has been found for Edward Howard or son Stephen in Onslow County. There are several papers selling land from Edward Howard and his wife Sabery. One James Howard bought several pieces of land and sold his ½ interest in mills and 300 acres of land granted to him.

One will for a James Howard in Onslow was found....

Will of James Howard in Onslow Co., N. C. Dated November 3, 1790. Mentions wife Elizabeth Howard. Leaves her "all my right and interest in a certain family of Negroes Mary & two children now in the State of Maryland being a part of Isaac Patridge's estate not yet divided. Also two beds and all the household furniture now in Newbern being part of said estate that formerly belonged to my wife Elizabeth. Son Josiah Howard, daughters Molsey Green, Fanny Howard, Carsey Howard, Harriott Howard, children under 18. Brother-in-law Frances Brice & son Josiah executors. [THERE WAS NO PROBATE, THIS IS AN UNRECORDED PAPER]

Surry County Census shows no Jesse or Joseph Howard in 1800.

In 1810 we find Jesse Howard with 1 male 10-16, 2 males 16-26, 1 male 26-45. There is 1 female under 10, 1 female 10-16.

In 1820 Jesse Howard was listed with 1 male under 10, 1 male 26-45, 2 females under 10, 1 female 16-26. Joseph may have been living with Jesse when the 1810 census was taken.

In the 1820 Census Joseph Howard was listed with 1 male 16-26, 1 male 26-45, 2 females under 10, 1 female 16-26.

Surry County, N. C. taxes; the first year that Jesse Howard was found paying taxes is 1813, it could have been earlier since the 1801-1812 taxes have not yet been compiled. Jesse was in Captain Calloway's District paying on 700 acres and 9 polls.

In 1817 Joseph Howard was listed immediately after Jesse Howard with one white poll. Jesse Howard was paying on 1 white and 2 black polls and continued to do so for several years. Could this mean that when Jesse and Joseph Howard came into Surry they brought some other relatives with them?

There are two estates for Jesse Howard in Surry County, N.C. one listed for the year 1814. There is an administrators bond stating that Isaac Copeland is appointed administrator and a small inventory in this record. Jesse died possessed of his wages in the service until his decease, \$24.00. Three coats, 1 shirt, 1 hatters bow and other materials, 1 ax, 1 hammer and pincers. This researcher does not believe this to be the Jesse Howard that came from Onslow County, NC.

The second estate for Jesse Howard in Surry County is dated 1832. This estate has a petition for dividing the lands of Jesse Howard. It states that this is the petition of Joseph Howard and Isaac Whitaker who petitions in the right of his wife Molsey Howard and Sally Howard and Jesse Howard by their guardian Joseph Howard Senr. This will help age Sally and Jesse since they were not 21 years of age at the time of their fathers death. The first petition asks for the division of the negroes of the estate of Jesse Howard. Names of negroes were Since?, Saml, Isaac, Gustin and Luke.

Another petition states that Jesse Howard died possessed of the following pieces of land; 97 acres on Arrarat River and the North Bank of Rocky Creek and another tract of 547 acres more or less. When this land was divided 247½ acres was allotted to Sally Howard with a value of \$400.00. Joseph Howard was allotted 100 acres with a value of \$400.00. Jesse Howard received 115 acres with the same value. And the last heir Isaac Whitaker & Molsey his wife was allotted 145 acres of land with the same value. Further research may prove me incorrect, but this researcher believes this to be the Jesse, son of Edward, who came from Onslow County, N. C. to Surry County in the early 1800's.

In addition a Will for Jesse Howard can be found in Surry County, N. C., on microfilm only, book 4 page 102, the original did not survive.

This will states....."The last words of the departed Jesse Howard relating to the distribution of his propperty among his children was as follows that there should be an equal distribution set aside of Ellina (smudged, the will book may have this and it should be more readable) which she should have one half part of either of the others. We the undersigned do think that the above departed was in his propper mind as we were present when the words were spoken and the undersigned ask^d the above departed Jesse Howard what part he wanted Eulina? to have that is should she have an equal part; his answer was no. But she should have a half share with the other children. The above words of the departed was spoken on the 17th December 1835 which on the night of the same day about midnight the above Jesse Howard died. Signed Micajah Reeves and Jo^s Howard." This cannot be the will of the above Jesse Howard who died with 5 negroes and 644 acres of land since the first record in his estate dates to the May court in 1832.

Adams, of the Indian Show Turns Up.

Last Christmas an Indian Show, from Nebraska, struck this section. It was in charge of J. Adams, a native of Surry county, and whom we found a very pleasant speaking gentleman. It was about January 12th that Adams left Wilkesboro in advance of the show, and from that time until a few days ago had mysteriously disappeared. The concern continued to exhibit under charge of another wild and wooly Westerner by the name of Wig. Friends of the missing man started out in search of him and H. Weaver, of Nebraska has just discovered Adams at Kershaw, S. C., at work on a rail road to get money enough ahead to reach home. He claims to have had \$15 when he left Wilkesboro and runing out of funds wrote repeatedly to Wig for advances. did not reply and continued to circulate the report of Adam's disappearance. This is the report that the newspapers are giving. The most mysterious part to us is that a man with as much intelligence as Adams appeared to be in possession of, did not communicate direct with his friends, and especially after getting upon the lift in S. C.? Be that as it may, Adams has headed towards his ranch a sadder and wiser man and it is safe to say, will not shortly engineer the noble red man around again upon an inspection tour or place his confidence in men of Wig's make-up.

(Article dated 3-16-1873 or 1893 was published probably in a newspaper perhaps in Winston or Salem per other articles. The articles were found in the Adams vertical file in the SCGA research room in the library at Surry Community College.)

Re: Sharing Your Heritage Hembys in Delta County Spring 1996

My students have been working to investigate an incident in the I860's. In I860, Delta County was part of Lamar and Hopkins Counties. My students would like to know where the Hembys originated and what happened to these people after the Civil War. Since the name Hemby is relatively uncommon, they have chosen to investigate this name rather than attempt to track the other characters involved. Additionally, they recognize that the name Hemby can be spelled a number of different ways (Himby, Hembree, Hamby ect.).

Some of my students will graduate in May of 1996, but I am going to retain copies of all their research, and this will be an ongoing project. Eventually copies of their research will be part of the historical collection at the Delta County Public Library in Cooper, Texas, because of its historical value. We have been fortunate to have had wonderful additions from Hemby families from many parts of the country. However, many of our questions about this family still remain.

I would like for you to place our letter in your files in hopes that someone will eventually contact you about the Hemby family or know a Hemby family historian. We have included the Hemby family information from the Texas I860 Lamar and Hopkins Census Records. Also we have included some other information that might be helpful to others. Additionally, we have included some information about the Howard family(another family that interests us). Please note that we have included the J. W. Hemby family. This family remained in the area, and we have collected information from this family. However, they know little about the other Hemby families.

We only found one Dennis Hemby in the 1790 North Carolina Census. He was in the Fayette District, Anson County. He was listed with one male under age 16 and two females.

You did not give us information on names in the Howard families. There were Howards in Surry County. Some information is enclosed as to names and the sources where they were found.

We are sorry that we do not do in-depth research but we do try to answer specific questions that do not require a lot of research. Your project sounds very interesting and we will be happy to place your letter in our file as well as submit a query for our quarterly journal.

We wish you luck in your very worthwhile project and if you feel we can help you in the future please write again.
