Keep in mind that Surry County, North Carolina was formed from Rowan in 1770. (There is also a Surrey County in Virginia, located in the Easter part of the state on the James River.) We search for names in census records, tax lists, graveyards, Bibles and various county records.

### William Freeman

William Freeman was born in Chowan County, N.C., in the 1730s. He died in Surry County in 1802. We have more information on William Freeman who came to Surry County in the mid to late 1770s at the request of his brother Samuel Freeman who had already been here some years. Samuel's children were leaving to join the great rush for land, south and west.

William's wife was Sarah Williams. They were married in Chowan County in 1762. William had 550 acres of land on the 1800 tax list. He bought some land from Samuel and others and lived on it at Siloam somewhere in the neighborhood of the old Methodist Church that Bishop Asbury is said to have visited on one of his trips to North Carolina in the 1770s.

William Freeman was busy being a juries and other duties at the courthouse. He would have been highly educated for that period of time and place. William died in 1802 and named wife, Sarah, in his will and ten children. The children are: Josiah, William, Tyre, Noah, John, Richard, David, Kiddy, Mitchell, Polly and Penelope Haines. See Surry County NC Wills 1771-1827 by Jo White Linn.

Ginger Freeman Shores of the Mountain Park community has given us vital information on the roots of William Freeman's descendants in Surry County today.

Of these 10 children, only David,

Tyre and Penelope Haines (wife of Nathan) are listed as being at the sale of William's estate. Their mother, Sarah, was there, too. That is all we have on the older generations.

Now we will go to present the present generations of this family with a very welcomed letter from Ginger Freeman Shores. We had asked her about it.

She writes: "Here is the information I have. My grandpa, Hugh David Freeman, was the son of Vance Washington Freeman. His parents were Elisha Freeman and Mary Callahan. They had children Ezekiel, Spencer, Hugh, Mark and Suesa. Ezekiel is buried at Welcome View Baptist Church.

"Zeke" Ezekiel was a Civil War veteran and was written about last month. Ginger's line goes (1) Ginger, (2) Willie, (3) Hugh David, (4) Vance Washington, (5) Ezekiel David, (6) Elisha, (7) David and (8) William. That is eight generations. Ginger's children make nine generations.

Welcome to Family Information Swap. Here we share family information in hopes that our readers will find facts and records that win document their family lines.


This summer has been taken up with questions about the Freeman family in Surry County. Becky Perdue of Gladehill, Va., is searching for a link to her William Freeman who was killed in the Civil War. He was last living in the Swan Creek area of Yadkin County. She thinks he is part of the Surry County Freemans who came to Surry County Freemans who came to Surry County from Chowan County N.C. in the 1770s. Also Valerie Gillespie Allman of Rural Hall is searching David Freeman and his descendant.

Last month we discussed Samuel Freeman and his descendants who remained in Surry County. As promised we will now discuss William Freeman and his known descendants who remained in Surry County.

To show how these two men were related we will go back a couple of generations to the grandfather of Samuel Freeman, John Freeman of Lower Norfolk County, Va. We can prove the relationship of this Freeman family by the deeds, wills, and court records found in Lower Norfolk County, Va., and Chowan County, N.C., as well as our own records found in the Surry County Courthouse. Most of the original documents for these counties can now be found in the State Archives in Richmond or Raleigh.

John Freeman and his wife Hannah (maiden name not known) were living on the western branch of the Elizabeth River in Lower Norfolk County, Va., by 1673. It appears that they were both dead by 1711 when their son William made deeds of lease and release of his father's land to his brothers John" Jr. and. Thomas. We do not know of any female heirs. Thomas remained in Norfolk while John, Jr. removed to Bertie County, N.C. Since William continues the line of Freemans who moved to Surry County, we will only go into detail with his family.

William Freeman (son of John and Hannah) married Mary Cording, daughter of Thomas Cording of Nor-

folk County, Va. This information came from a court record found in the Norfolk records. William. made his will in 1736 naming his wife Mary and his six sons as heirs. To his oldest three sons, John, William, and Thomas, he gave to each "the plantation where on he now lives." So these three men were already full adults living on their own. To his fourth son, Richard, he gave "the plantation whereon I now live to be delivered to him at the change of my well-beloved wife Mary Freeman's condition either by death or marriage." The youngest two sons were given a 640 acre tract of land in Bertie County to be shared equally when they came to adulthood.

We learn from the Chowan County deeds that Mary Cording Freeman must have died about 1741 for her eldest son John made a deed to his 'brother William on 18 August 1741 "in full compliance of last will and testament of William Freeman, deceased, being the lawful father" for land on the south side of Catherine Creek Swamp adjacent to Thomas Freeman "brother of John Freeman and William Freeman... and a tract in occupation of Richard Freeman and brother to both parties...." The tract was also adjacent to Walter Draughan.

After buying land in both Bertie and Granville Counties, N.C. Samuel Freeman youngest son of William and Mary Cording Freeman, was living in Surry County by 1771.

Samuel's eldest brother, John, remained in Chowan County where he and his wife Tabitha (maiden name not documented.) raised their family. John was elected to the Vestry of St. Paul's Church while the church building was being built in Edenton. He was a prominent man in his community. He wrote his will in 1777 and names his six children: William, Jacob, John, Zilpah Outlaw; Tabitha Mansfield, and Priciller Hinton.

It was John's son William who moved. to Surry County less than a year after his father's death. His Uncle Samuel sold him 100 acres on Hogan's Creek on 8 August 1778. William also received a State of North Carolina patent for 167 acres adjacent to his own land. (It is also noted here that William's brother Jacob came to Surry County as he received a State of North Carolina patent of 200 acres on Hogan's Creek in 1784. We do not know what became of Jacob Freeman.)


William Freeman, son of John and nephew of Samuel, and his wife Sarah Williams Freeman lived in Surry County until their deaths. William made his will and died in 1802. In his will he named the following heirs: son Josiah, daughter Kiddy Mitchell, son William, wife Sarah, son Tyre, daughter Polly, daughter Penelope Hains, and Noah; John, Richard and David.

Tyrc was to receive the home plantation at his mother's death. Of the seven sons of William and Sarah Williams Freeman, only David lived his entire life in Surry County. Tyre remained until 1840 when he moved to Oglethorpe County, Ga.

Other than the descendants of Samuel Freeman who remained in Surry County, one could safely say that the remaining surnamed Freemans were descendants of David Freeman.

We learn more about David Freeman and his family in deeds, marriage bonds and tax lists found in the Surry County records. The tax lists for the years 1835 to 1841 show David Freeman living in the Rockford district. In 1835 David is taxed with 100 acres and 1 white poll. Listed just above David is his son Elisha Spencer Freeman with no land and 1 white poll. By having no land we believe Elisha was either living with his father or at least living on his father's land.

Elisha Spencer Freeman married Polly Kellehan (Callahan), marriage bond dated 19 March 1830. David See FAMILY, page 7

Freeman also had two daughters with marriage bonds in Surry County. Lucinda Freeman married Crawford Wall, and Mary Freeman married John Reid. We find David as a widower living with daughter Mary Reid in the 1860 census.

Our purpose here was to bring documented data about the early Freeman family in Surry County up to the time of David Freeman. Information about other descendants of David Freeman has been printed in previous columns.

Local History We've had students tell us that the book, Surry County Soldiers in the Civil War, has helped them in studying about the soldiers. The book has letters 'Written by the soldiers telling about the war. Many of our loved ones were in it

This brings to mind the importance of saving local history and family histories. We hope families will work together and have their stories saved in print like the book *William Whitaker and his Brother Jonathan Whitaker of Surry County*. This book has been out of print for some time, but reprinting is on the way.



I apologize for taking so long to thank you for the two Wills and other information that you have sent to me.

Journal

I have already asked North Carolina, Virginia, Georgia, South Carolina, & Tennessee, to see if Charles Lay's records for the American Revolution were there with no luck. Many states said they had a lot of missing records.

I went to our National Archive and found three damaged Lay documents. Unfortunately they were too damaged to be anything but photographed. Also, the only name on the cover was Lay. No help there.

I have been told that my Nancy Freeman is the daughter of William Freeman. She first married Charles Lay. Her second husband was William Anderson. You will find her on page 82 of "John Freeman of Norfolk County, Virginia" book. I have the marriage license from Orange County. I have sent for William Freeman's Will from the North Carolina Archive and as yet none has shown up in my mail box. Since I am out of state it cost me \$20 for each inquiry.

Once I get the proof of her parents, I will need to know if William Freeman served in The American Revolution and get a copy of that record. The North Carolina Archive will say to me, "What Regiment was he in?" I will only be able to say he lived in Orange County. The trouble is, did he live there while serving in the American Revolution? He may be the William Freeman in Surry County and moved later.

On page 82 it mentions 35. SARAH FREEMAN. It says "she was named as Sarah Haise in her father's will. She is probably the Sarah, named as wife of Hardy Hayes in his will written 7 March 1784 and proved in Bertie County". I need to send for this will, but only if I find out if her father Hardy Hayes served in The American Revolution. I am trying to save this history. Maybe her father is already in the DAR. Again, how do I prove that she married William? Maybe N.C. has a marriage record. They have so few that I would not count on it. These three questions will cost \$60.00 from the N.C. archive. I wonder where William Anderson served during The American Revolution. If, he served in North Carolina then he must have received land in Tennessee. I wonder if this was still true if he served in the Militia.

You people have been so kind to help out. I thought you would be interested in what I have found out so far. It is very important knowing that men who fought in N.C. received land in Tennessee. Thank you for this help!

A large number of minor cases, appeals from magistrates and recorders, have been disposed of and many cases not pressed for the lack of witnesses or the escape of the defendants. 

He grew up in Dobson, graduated from Surry Central High School in 1963 and received his bachelor's degree from Wake Forest University and his master's degree from UNC-CH. He taught school in Stokes and Forsyth counties before going to law school at Wake Forest.

He practiced law in Winston-Salem for two years, 1974-1976, when he was elected as a District Court judge. Gov. Jim Hunt appointed him a special Superior Court judge in 1980. He was elected to a seat in the 21st Judicial District in 1982 and was recently reelected to an eight-year term.

Judge Freeman seemed pleased to be with the group, made up of people he went to o school with - teachers, neighbors and family. He told some tall tales about Dobson politics and some funny jokes and some memorable, hilarious jokes. There were some jokes he would not tell because his mother, Ruth Freeman, was present. Bill is also the son of the late Robert A. Freeman Jr. and the grandson of Robert A. Freeman Sr., also a lawyer.

In law school, he said he was told there are three things a judge must have: a gray beard or gray hair for a look of wisdom earned by years of learning; a strong bladder, to learn patience; and hemorrhoids, to bring on a look of serious concern.

In a question-answer session, Judge Freeman explained that a Superior Court judge travels to the courthouses in county seats to hold court at a set time, that the time the court is to be held in his district is set. He does not make the decision on life or death cases. The jury does that. He does pronounce the sentence.

In answer to a quesition about the most serious problems that arise, he answered that they arise from drugs, alcohol and guns. Being a judge is a serious responsibility not lightly taken; thus, the necessary diversion of jokes.

Judge Freeman has a sharp wit and is a great story teller. The group thoroughly enjoyed his visit to Dobson. President Hothem thanked him for coming. Rachel Earnest won the door prize.

## **Surry Native Climbs Political Ladder**

RALEIGH – Sitting under a framed photograph of the Surry County Courthouse in Raleigh, Franklin Freeman held up a silver pen with gold-plated trim. Across the hall from Freeman's office in the state Capital, Gov. Jim Hunt had just used the pen to sign the first bill endorsed by any North Carolina governor since colonial times.

The boy who once chased his escaped sheep across the courthouse lawn in Dobson now had captured a piece of state history. During the signing ceremony, Hunt handed the pen to Freeman, his new chief of staff, saying, "He's a history buff."

"Just think," Freeman said back at his office. "This is the pen used to sign the first bill." The bill, the first passed this year by the General Assembly, spelled out the timetable for signing or vetoing bills. "This is something as time goes on that I will take out and show my grandchildren," he said.

There will be other stories for Freeman to tell as well. As Hunt's new chief of staff, he The boy who once chased his escaped sheep across the courthouse lawn in Dobson now recently captured a piece of state history. 3-3-97

will be seeing plenty of North Carolina history in the making. And, he will be making a bit of history himself. For instance, Freeman put the state seal on that first bill.

Freeman, the son of a Dobson lawyer and a school teacher, already has built quite a legacy in Raleigh over the past quarter-century through his work in a number of high-level state government posts.

Then, he got a surprise call from the governor in December.

Freeman had been a member of Hunt's cabinet for four years as secretary of the prison department. Now as Hunt was building a staff for his final four years as governor, he decided to bring Freeman to the Capital to be legal counsel. Three weeks later Hunt called again to offer Freeman the additional duty of chief of staff.

Now Freeman spends his days discussing policy with the governor and relaying Hunt's directives to other government officials. The first staff member that the governor sees each weekday morning is Freeman at their daily 8:15 a.m. meeting in the Executive Mansion.

"It's very exciting, very energizing," Freeman said after one month at his new job. "It is a job where you're right at the center of what's going on in state government. It's an opportunity to be part of an historical time."

Freeman is well acquainted with politics and being in the seat of power. He was born into politics and government, growing up in a house just off the courthouse square in Dobson.

"The discussions you have, being in a government town, was centered around government, politics and what was going on in the world, the county," Freeman said.

The young Freeman hung around the courthouse, watched his father argue cases in court

and took part in political rallies.

He keeps in his Capital office a poster of U.S. Supreme Court justices that once hung in his grandfather's law office in Dobson.

Also hanging in the old treasury office in the Capital is a campaign poster of Freeman's father, Frank, who became one of the first district court judges in Surry County.

Those mementos join not one but two photos of the Surry County Courthouse, and Freeman breaks into a smile and his eyes glaze when he begins to talk about his hometown and his childhood.

"Dobson was an idyllic town to live in," he said.

Even in town, Freeman enjoyed carefree country living in the 1950s, keeping as many as 10 pigs in a pen behind his grandmother's house for a 4-H project. He drove mule teams to cut hay and gather tobacco. And he ran a paper route, making his rounds at the courthouse and in his neighborhood on horseback.

"I had a pony," said Freeman. "I could just lay the reins on him and he knew the route. I just sat and threw the papers."

Later, when the government was encouraging farmers to raise wool, Freeman bought a flock of 10 sheep at a stock sale in Jefferson. His flock grew to almost two dozen. He butchered lambs for meat and sold wool to Chatham Mills in Elkin. Freeman returns to Dobson about every other month or so to see his mother, Clara, 88, who still lives in Freeman's boyhood home. His siblings live elsewhere, but Freeman still has some relatives nearby, such as Elkin lawyer Joseph Freeman, a cousin.

"Surry County and Dobson, to me, is one of the finest places on earth," the chief of staff said.

As a young man, Freeman aimed to become a veterinarian, but when the time came to go to college, he decided to attend the University of North Carolina at Chapel Hill and become a lawyer.

Fresh out of law school, Freeman attracted the notice of Dan K. Moore, a former governor who had become a state Supreme Court associate justice, who offered Freeman a job as a clerk.

Freeman later joined the district attorney staff in the Surry area, then went back to Raleigh to be administrative assistant to Supreme Court Chief Justices William Bobbitt and Susie Sharp.

Freeman ran and won election as district attorney in the Surry area while still in Raleigh. But Freeman did not serve out his term before he was called back to Raleigh by Chief Justice Joseph Branch to run the Administrative Office of the Courts, which oversees the state's entire judicial system.

After a dozen years, Hunt called oh Freeman to run the prison department.

"Now you talk about something coming out of the blue," Freeman said. However, the Surry native had built a reputation in the state Capital as a bright and capable administrator. As prison secretary, Freeman helped plan the state's most massive construction program ever and put into action such novel ideas as shipping inmates to other states to relieve North Carolina's chronic overcrowding problem. Today, there is a surplus of space.

In announcing his new job in January, Hunt called Freeman "one of the best administrators and negotiators this state has ever seen."

With a deep and resonant bass yoice, Freeman also became a coveted after-dinner speaker in Raleigh. His stories and jokes are legend in the Capital, but Freeman is best known for his mule tales.

As a boy, Freeman would drive his grandfather's mules in the country and later found work with dentist Carl Folger, driving his mule team for \$5 a day. The mule tales got their inspiration from those times.

"I took stories and adapted them into the mule stories," Freeman said. "I site them in Surry County even though most didn't happen there."

Freeman will only be 56 years old at the end of Hunt's term, but he won't talk about future plans. His family owns land in Lowgap, but Freeman is not thinking retirement.

"Somebody told me the best politics is to do your job well," said Freeman. "My philosophy is, 'You do the job the best you can and the future will take care of itself"."

Surry County has not had a native son as governor since 1821. That's a bit of history Freeman might appreciate.

Hello, I have finally (I feel) gotten some information that might be of interest to everyone looking for the Freeman's of the Yadkin River. This is what I now call them....ha. In the census of Rowan Co. NC in 1855-1859-there were Samuel, John and Jona. Freeman. We know who Samuel is now I feel that John is the brother of William, but could also be the brother of Samuel. You will see later why I think it is William's brother. As we know Samuel was a large land owner in Surry Co. along the Yadkin River. He sold William married to Sarah Willilams, his nephew 100 acres of land from his holdings. All of William and Sarah's children went into Ga. except for David who remained in Surry Co. until his death and no information on their son John and where he settled. Tyre inherited the lands and plantation where William and Sarah lived but left for Ga between 1830-1840. The other land he owned was divided between Noah, John, Richard and David. That would have been about 25 acres each. Also in Surry Co. in the I790 census was William's brother Jacob who had land in I780 on Hogans Creek. I did not know of this brother being there, and have no information on his children and if he remained in Surry Co. or not. Next we have William's brother John who I mentioned above who had children in Rowan Co. in the I760's. John his son bought land 20 miles S. of today's Salisbury along the Yadkin River. Next he obtained land on the Yadkin River at Trading Ford and settled there. He died at the age of 30 leaving no will or list of his children. His brother Aaron was also in Rowan and married there in 1769. He got license for a Taveren in 1774 on the Yadkin and ended up in Iredell Co. He later moved to Buncombe Co. NC and died there he fought in the Rev. War and has a marker for this on his grave. Their brother Moses was also in Rowan Co. in the 1760's and lived in Wilkes Co. All of Aaron's children were either born in Rowan or Iredell as were Moses's. Then their is an Isaac Freeman which I think is a brother of these people that had land on the Swann Creek waters which would now be Yadkin or Wilkes Co. He also fought in the Rev. War and was killed in 1885. So as you can see brothers and nephews helped settle Surry, Yadkin, Wilkes and Iredell Co. I have information on some of the decendents of these people and will put it all together when I can. Now my William R. Freeman married to Hannah. First found in Montgomery Co. in the I850 census with some of their children. In 1810 census there were two John Freemans. One was John H. Freeman married to Elizabeth and a John Freeman, Sr. married a least 3 times. In the I850 census they would have been in their 60's which would make their birth dates in the I780's the right age to be some of the decendents of William, Samuel, Aaron and Isaac. When my gg grandfather returned to Yadkin Co. by 1860 he obtained land and after his death in the civil war, Hannah got the land by deed from E. B. Hampton and wife Alice. Isaac Austin held the bond. It was then deeded to my g grandfather William Howard Freeman and wife Martha Rebecca Blackman Freeman. I believe William H. paid the bond off. Don't know. This land is on the Swann Creek Rd. in Jonesville near Swann Creek Baptist Church. Then in 1908 William Howard deeded 24 acres more or less for \$1.00 to E. F. McNeer and wife Maud. This land was in Yadkin Co. adjoining the lands of E. F. McNeer and John C. Bodenheimer and others and the McNeer land was in Surry Co. with this land adjoining it on lines. I don't know much about where the lines are for Yadkin and Surry but I don't remember William H.'s land being close enough to Surry Co. for it to adjoin a line there. If this was another parcel of land he had, I wonder if over the years it was left to his heirs before him. This might be my answer of where I came from, beginning to believe we were all just hatched.... My mind just wonders if it could have been land of the I00 acres of William and Sarah or the I20 acres of Isaac and Agnes or some of Aaron's children. They all lived close even though the counties were different. We all know all these counties came off of Rowan and I wonder if the information is by todays counties. This is all for now, lets all think which would be the best way to find some of this information, tell me and I will go for it. Thanks again to all of you wonderful people that have taken your time to look things up for me, it has really meant alot. Hi Dan, and here goes ... there is so much I don't know where to start. I'll start in Montgomery Co. and give you what I have. Census: 1790 Hartwell Freeman left for Tenn. 1800 Russel went also to Tenn in 1820-1830. 1810 John, John H. and James, 1830 Daniel, Henry and both John's, 1840 John Sr. John H., Lewis no William, 1850 William and Hannah, John H. age 65, John Sr. age 6I, Henry, Mary and Sewell. Now the John's, Mary and William all lived in the Pee Dee Township. Mary Freeman was a widow with the following children: Elizabeth, Rueben, Catherine, Isaac, Branson, Lydia, Daniel and DAVID, she was 42 and remained in Montgomery Co. until she died. William and Hannah both to be 33 had the following children: Robinson, Jesse, Mary, DAVID, Martha, Emory, Spinks, Hannah, William Howard, my g grandfather and Cintha, born either right before or after William was killed in the war. Now in the I840 census of Surry Co. there was a William 20-30 with 2 more males 20-30, one female 20-30 and 2 females under 5. Sounds like brothers or cousins living in one house? I think it is interesting that there was a William along with David and his other sons Iredell and Elisha who had a son also named David, in the tax list for 1837 and 1838 and did not appear with them after that. All of William and Sarah Williams Freeman's children went to Ga. except for David (Surry) Tyre did go in between 1830-1840 and no information on their John and where he settled. He was not at the estate sale when William died, and Tyre got the large plantation from William. Wonder what happened to the land? Also there was 100 acres that was divided between John, Noah, Richard and David. Wonder what happened to that? The Aaron from Iredell also had a grandson named David, can't trace him as of now. There was a David in Mecklenburg Co and he died there that was a brother to Aaron (Iredell) still haven't been able to trace his decendants except for his son David, Jr. that stayed in Mecklenburg Co. Isaac also a brother was on Swann Creek but I found Isaac's widow and brother Moses in Davie Co. in the I790 census. Also there was a Thomas Freeman in either Yadkin or Wilkes in I790 census. I guess what I am trying to do is eliminate the David's since both William and Mary had sons named David as did Elisha. Now to William R married to Hannah. Why did he come to Yadkin by 1860, mabey family. I haven't been able to tract Hannah but in the 1810 census of Surry there was a James Durham and a James, Jr. and in 1810 a Micajah Durham. I wonder what happened to John William and Sarah's son, as the John H. Freeman married to Elizabeth appeared in the I8I0 census of Montgomery and William and Sarah's son married an Elizabeth Isabell or Elizabeth Cawley, never have found which one. We know that William married to Sarah, Jacob and John all brothers were at one time in Rowan (Surry) as well as Samuel, their uncle. David Freeman's grandson Hugh was killed one day after William R. both at Spotsylvania Court House battle. William R. first enlisted in Iredell but when he went back in after he went awol, he was in Co. A. 44th Reg. Infantry, this is what is on his papers I got from the Archives. I think that famililes stayed pretty much together in the war. Is this as confusing to you as me. Now the Montgomery tie, the children off of John and Tabitha Freeman, William, Jacob and John would have been one half Native American, her father being the chiefman of the Chowan Indians. If a person had one drop of Indian blood until 1937 they were considered free black. Isaac was determined to be free black even though he fought and died in the Rev. War. In the I830-I840 many people with indian blood hid in the mountains etc. so that they would not have to go to reservations. The Uwharrie Nat. Forest in Montgomery Co. was full of Native Americans during this time and a really good place to go and hid if they didn't go to the mountains of NC, Tenn and Ga. Food for thought. I have always been told that we had Indian blood in our line of the Freeman's. More food for thought. Now I am going to close but there is so much more I have, I just don't know where to apply the information to. You think about all of this and get back to me and let me know what you think. This was a large family and appeared to have lots of land where ever they lived. John and Tabitha were in Bertied Co. in NC and I wonder why all their children left with them having so much property there. 

Tracing lines back is the business of a Genealogical Reasear her so, of course, I think that you should try and go back. While thinking (Out Lawd) about the Freemans and talking to JoAnna McDaniels one day, she said that she was interested in try ing to do the job so I hired her.

Wake Co. records etc. are incomplete as I think she has explained in her report, along with Johnson Co.

With all the records JoA. checked and read, we found no proof of when John Freeman came to Wake Co. area. It is the only way left in which we might be able to pin down his past and ancestors.

#### **Freeman Family**

We have had so many questions about the Freeman family in Surry County we want to give some background information that may help understand this family history. Lucile Freeman Newlin and descendants of Samuel Freeman wrote their history for the *Heritage of Surry County* in 1982. The information below came from her research.

William Freeman of Chowan County, N.C., wrote his will in 1736 naming six sons including Samuel and William Freeman.

Samuel Freeman owned land ir. both Bertie and Granville counties in the eastern part of the state. He sold those lands and began buying land in Rowan County, now Surry, in 1761. He acquired several tracts of land along the Yadkin and Ararat Rivers until he owned 2,000 acres.

Samuel Freeman was active in civic affairs and served on the Con<sub>1</sub>mittee of Safety for Surry County. He was a member of the committee appointed by the governor to erect and furnish the public buildings for the first county seat of Surry County in 1771. that was Old Richmond, which is now in Forsyth County.

At age 62, he enlisted in Dixon's Co. 1, NC Batt, commanded by Thomas Clark. he fought at the Battle of King's Mountain. After the Revolutionary War was over he continued to serve his community and state well.

He wrote his will in 1796 naming his three sons and two daughters. Using the Surry County NC Will Abstracts by Jo White Linn of Salisbury, here is the abstract of Samuel Freeman's will from the Surry County Will Book 3, p. 19a.

"Will of Samuel Freeman, 8 March 1796. Wife — Elizabeth. Daus: Rachel Early, Nancy Hughett, Nanny Badgett (wife of James Badgett). Dau. Rachel Early's four children: Asa, Lion, Sarah, Elizabeth. Three sons: Joshua Freeman, James Freeman, Aaron Freeman. Exers: Wife Elizabeth, son Joshua and Jacob Sheppard. Wit: Edward Smith, Mordecai Richards, Chr. Isabell. Prvd by Smith. Rec. May Ct. 1796."

Of the sons of Samuel Freeman, only Aaron remained in Surry County to raise his family. All the other male Freemans removed to Davidson County, Tenn., and other points west. Aaron Freeman married Nancy Hawkins of Hillborough and had the following children: Polly married William Cunningham; Rachel married Jacob Beamer; Abner married three times, the last in Tennessee; Alexander Hawkins Freeman maried Sally Moseley and they remained in Surry County.

Three of Alexander Hawkins Freeman and Sally Moseley's children remained in Surry County: West Freeman, Alexander Hamilton Freeman and Samuel Aaron Freeman.

West Freeman (1820-1857) married Virginia Franklin. Their children were: Virginia Freeman married Gus Hatcher; Benjamin Alexander Freeman married Frances Dix, their children: West (died at 19), Ruth m. Walter Snow, Virginia Freeman m. Gray Younce, William Jennings Freeman m. Elsie McClarety, Sarah Freeman m. Orb Blackbourne, Rachel Freeman m. Warren Nowlin, Lee Dix Freeman m. Charlie Mae Strickland.

Alexander Hamilton Freeman (1836-1915) married Elizabeth Martin Waugh (widow of Col. James Waugh, MD) and their children were: William Richard Freeman not married; Sally Rebecca m. William Lamont; Edna America Freeman m. Brady Norman; Calohil m. Herbert Hassler; Robert Alexander m. Bessie Willis.

The third son of Alexander and Sally Freeman to stay in Surry County was Samuel Aaron Freeman. he married Susan Waugh. Of their seven children only three lived to adulthood: Luther Waugh Freeman m. Etta Hauser, they went to Missouri; Sallie Victoria m. Dr. Walter Coke Folger; Richard Columbus Freeman m. Maude Folger.

Richard Columbus Freeman and Maude Folger had 10 children: Margaret Freeman m. William Poyner; Rachel Freeman, unmarried; Richard C. Freeman Jr. m. Lena Whitley; Susan Freeman, unmarried; James N. "Buck" Freeman m. 1st Lillian Perry, 2nd Shirley Kennedy; Dr. Brooks Freeman m. Elizabeth Townsend; Clara Freeman m. Carter Hudgins; Franklin E. Freeman m. Clara Smith; Joseph William "Bill" Freeman m. Dixie Brown, and Virginia Lucile Freeman m. Grier Newlin.

## Retired district judge, civic leader, 75, dies

DOBSON - A retired Surry County judge and distinguished civic leader died Thursday night at Northern

Surry Hospital in Mount Airy. Franklin Edward Freeman Sr., 75, South Main Street, Dobson, was found unconscious on a sofa at his residence by



Surry County EMS workers summoned about 9 p.m. Thursday, a spokesman said this morning.

Freeman was taken to Northern County School Board chairman. Surry Hospital where he was pronounced dead at 10:30 p.m.

Freeman, known affectionately as "Frank," was an attorney for more than 30 years before retiring after his second term as district court judge. He continued serving as a backup judge until his death.

His years in public service included five years as Judge of Recorders Court, 20 years as Government Appeal Agent, four years as chairman of the Surry County Democratic Party, a year as state chairman of the Young Democrats, president of the 12th District N.C. School Board Association and 20 years as Surry

A former mayor of Dobson, he mounted an unsuccessful campaign for Congress in the 5th District in 1964.

He was a member of the district, state and American Bar associations and a member of the American Judicature Society.

Freeman's compassion on the bench is remembered by attorneys in the area who worked with him.

"He was probably the most compassionate man you'd run into,' Elkin attorney Lewis Alexander Sr. said this morning. "He was always thinking about the person before him, yet he was tempered with justice."

Surry County clerk of court David Beal said this morning Freeman was "one of the last statesmen."

"He had an attitude of concern and compassion for those he dealt with which was recognized throughout the state," Beal said. He noted that Freeman was interested in the defendant and inquired about family and circumstances.

"Since he grew up here he knew the people he dealt with and had insight into their problems," Beal said.

When Freeman withdrew from his third race for district judge in 1978,

Freeman's compassion on the bench is remembered by attorneys in the area who worked with him.

"He was probably the most compassionate man you'd run into," Elkin attorney Lewis Alexander Sr. said this morning. "He was always thinking about the person before him, vet he was tempered with justice."

Surry County clerk of court David Beal said this morning Freeman was "one of the last statesmen."

"He had an attitude of concern and compassion for those he dealt with which was recognized throughout the state." Beal said. He noted that Freeman was interested in the defendant and inquired about family and circumstances.

"Since he grew up here he knew the people he dealt with and had insight into their problems," Beal said. When Freeman withdrew from his

### Franklin Freeman named

He will bring thorough legal knowledge to post, Hunt says

RALEIGH

For almost 30 years, Franklin Freeman has worked in and around North Carolina's courts. And with Gov. Jim Hunt's appointment yesterday, Freeman will become one of seven justices who sit atop that court system.

Hunt named Freeman - a Dobson native who

serves as Hunt's chief of staff and chief lobbyist with the legislature — to fill a seat on the N.C. Supreme Court that will be vacated when Associate Justice Henry Frye becomes chief justice.

100

Hunt appointed Frye on Monday to fill the chief-justice post, which will be vacated when Chief Justice Burley Mitchell retires next month.

"Franklin possesses the strength of character, the deliberate temperament and the thorough legal knowledge to be an outstanding justice on our state's highest court," Hunt said in a prepared statement. "He has dedicated his ca-

to N.C. Supreme Court

reer to equal justice under the law and to fairness in public policy for our state."

In a telephone interview yesterday from Emerald Isle, where he is vacationing with his family, Freeman said he had thought about a position on the court but never counted on it.

"I think every lawyer harbors that dream, but the possibility is unlikely," he said.

Freeman said he will bring to the court almost 30 years' experience writing state policy and trying to avoid unintended consequences when it is implemented. His father was a district-court judge and his cousin William Freeman is a superior-court judge in Forsyth County, but Franklin Freeman has never worked as a sitting trial judge.

He said he has remained familiar with the law and court opinions while working to draft legislation as Hunt's chief aide and primary lobbyist with the General Assembly.

Freeman spent years working in the state court system before he became Hunt's chief of

staff in 1997. He went to work as a clerk for Supreme Court Justice Dan K. Moore as soon as he finished law school. He later worked as a prosecutor and was elected district attorney for a district that included Surry, Stokes, Rockingham and Caswell counties.

In  $2\frac{1}{2}$  years as a DA, he said, he saw that more than 150 cases — including 31 murder cases — went to juries. "I was in court 47, 48 weeks a year," he said.

As executive secretary to the state's Judicial Council, Freeman later drafted the state's deathpenalty law in 1976.

He also spent 12 years as director of the Administrative Office of the Courts, helping the office start its guardian *ad litem* program for abused and neglected children, as well as mediation and arbitration programs as alternative forms of dispute resolution.

In 1993 he became Hunt's secretary of correction, overseeing the biggest prison-building program in state history.

As inmates and employees pursued legal action against the state for prison overcrowding or personnel issues, he said, "I was probably the mostsued person (in the state). I read a lot of law then."

Despite its new composition, Freeman doesn't expect big changes in the court, he said.

"I would expect the work of the court to continue as it has for the last several years — primarily death-penalty cases and important civil and constitutional issues," he said.

Freeman said he probably won't surprise many people with his decisions.

"I don't think so. I've been in public-service work for 30 years. People have watched me. The press has scrutinized me," he said.

"I think my philosophy would probably be characterized as moderate."

When the justices gather to discuss cases, he said, "The collective decision-making process requires different perspectives, different life experiences. That collective experience sitting around the conference table results, I think, in the best decisions."

Freeman and Frye will both have to face state-

wide elections next year to retain their seats on the Supreme Court.

And Republicans, who already hold four of the seven seats on the court, are all but promising opposition.

"We would hope to field a candidate that the public would view as more qualified to sit on the high court," said Bill Cobey, the chairman of the state Republican Party.

Though the associate-justice seat currently occupied by Frye would have been up for election next year anyway, "What they've done is give us two seats to go after," Cobey said. "They've given us two bites at the apple."

Freeman recalled yesterday how his father once campaigned for office even in the late 1950s by riding on horseback from Dobson to the Surry County community of Beulah to Mount Airy and back to Dobson — a trip of more than 30 miles all in one day.

And he said is prepared for a statewide campaign next year, noting that he ran an unsuccessful campaign for state auditor in 1992.

"I have run a statewide campaign. I know what's involved now more than I did then," he said.

Hunt is expected to name Wayne McDevitt, his secretary of environment and natural resources, as his new chief of staff.

The parents were John and Hannah Freeman, and sons were Nathan, Daniel, Robert, probable children Samuel and John. Nathan was killed in the Rev. War in Capt. Veal's Company. A land warrant was issued in his name and on 30 August I796 Nathan's brother Daniel relinquished any claim to Nathan's estate to another brother Robert Freeman who pursued the claim, Robert, a resident of Surry Co. appeared before Jesse Lester and Daniel Bills, Justices of the Co. of Surry and applied to receive Nathan's pay and I00 acres of bounty land due him. Robert assigned his right to the land to Daniel Wheaton. He married a Susanah Gunston, Bondsman was Mos. Adams. I checked the census of Orange Co. and there were most of the children there but seemed to leave by 1830. David Sr. must have died in Orange Co. and his son Daniel Jr. left by 1830. A Daniel and Henry were in the census of Montgomery Co. the first time by 1830. Then the John in Orange left by 1840 and a John appeared in Montgomery Co. by 1840. Some food for thought. 
