Mrs. Betty Murphy had the misfortune to fall and break her arm Monday morning while walking in the yard at the home of Mrs. J.M. Hill where she was visiting. Two small bones of the left arm were broken near the wrist. A physician was called and the injury given careful attention.

News/Sep. 11, 1913: Mr. and Mrs. Ed Banner have rented MRS. BETTIE MURPHYS residence on Franklin St. and began housekeeping there the 1st of the week.

Oct 16, 1913: MRS. BETTIE MURPHY has agreed to keep house for Mr. George Graves and will assume her new duties the last of the week.

Aug. 17, 1933: Mrs. Betty MURPHY remains quite sick at her home on Franklin St. where she suffered a slight stroke of paralysis about 3 weeks ago. Mrs. Murphy has been a sufferer with high blood pressure many yrs and rendered almost helpless by a broken hip some 10 yrs or more ago. She is confined to her bed by the recent attack.

Nov. 16, 1933: Mrs. Betty MURPHY, wd of the late Wm. A. MURPHY passed away at her res. on Franklin St. this city about noon Sun. aged 71 yrs. She was crippled by a fall about 10 yrs ago and had been practically helpless for some time as the result of rheumatism, high blood pressure and her injury. She is sur. by an adoped dau. who lives in Idaho, and 1 sister, Mrs. Mettie Ashley formerly of Greensboro whose address is not known, and 2 brothers. Mrs. Ashley spent about a yr here taking care of Mrs. Murphy some 18 months ago. The funeral was conducted from the First Bapt. church Mond. afternoon at 2:30 by the Rev. J.R. Johnson and interment made in Oakdale cemetery. Messrs. Jim and Turner Murphy and W.A. & Roy Murphy, brothers-in-law, and nephew of the dec'd were called here from W-Salem by her death.

I received the papers on the above case which you so kindly sent to me. I cannot begin to tell you how much I appreciate your labors. I did have the Death Certificate for Betty, but the newspaper clipping about her and Mr. Murphy were a totally welcome surprise. I was not sure where they were living at the time of his death. We also had been told his death was from a totally different set of circumstances. My Mother was the adopted daughter, and unable to tend Mrs. Murphy in her later years, having the responsibility of several small children at the time, as well as overwhelming financial burdens. She did visit Mrs. Murphy in 1927. I have from many sources tried to find adoption papers for her, but to no avail. Rather, she was probably just taken to be raised by the Murphy's without the legal formality. Again, my most heartfelt gratitude for your labors - - THANK YOU!
