# **Proceedings**

OF A SPECIAL SESSION OF THE FISHER'S RIVER PRIMITIVE BAPTIST ASSOCIATION, HELD WITH THE CHURCH AT LITTLE VINE IN SURRY COUNTY, N. C. ON FRIDAY, DECEMBER 22, 1961.

Services were introduced with song and prayer by Elder Joel Simmons, Moderator of Piney Grove Association. Introductory sermon was preached by Elder James F. - 3. Reason for calling the special session of the Association was outlined by Elder James F. Hill, our Moderator.
- 4. By move, second and unanimous vote that we the Fisher's River Primitive Baptist Association withdraw correspondence from the Mountain Association and The United Primitive Baptist Association of Virginia, and all who affiliate with them due to the fact that they have been and are preaching with churches, groups, factions and ministers which have long since been declared disorderly by ours and corresponding Associations.
- 5. By move, second and vote that we recognize all churches that have shown by their practice that they didn't want to go with the disorder of the Mountain Association and The United Primitive Baptist Association of Virginia, and therefore stand for orthodox doctrine and practice.
- 6. By move, second and vote that we appoint a committee to inquire into the charges brought against Mates Creek Association by Washington Association, also the charges brought against Washington Association by Mates Creek Association, and the charges Roaring River Association brought against Mates Creek Association. The committee appointed was as follows: Elders J. M. Edwards, Coy Sikes, Deacon O. W. Sisk, Brethren Carroll Gardner and Curtis Harbour.
- 7. By move, second and vote that the Clerk have 900 minutes printed. One for each member of Fisher's River Associa tion and one for each church in corresponding associations.
  - 8. Collected from the churches, \$49.75.
- 9. On motion to read the minutes of the day. The minutes of the day were read and received by move, second and vote, thus becoming the work of the body. Signed by Moderator and Clerks.
