



On many occasions, when medical officers were extremely busy, Sergeant Christian, of his own volition, gave what aid he could until more extensive treat-ment could be administered by a medical officer. The exceptional skill, devotion to duty and intense loyalty to the wounded, as displayed by Sergeant Christian, re flects high credit upon himself and the armed forces.



Corporal Technician George Orville Collins, son of Mr. and Mrs. McKinley Collins, of Westfield, has just been awarded the Bronze Star medal "for heroic achievement in action", according to a letter forwarded to his parents from the headquarters of the 34th Infantry Division in Italy.

The citation for Corporal Collins, which was read at the presentation ceremony, declared that the award was "for heroic achievement in action on May 25, 1944, in the vicinity of Campo Morto, Italy. A lieutenant in the company to which he was attached was seriously wounded while on an open ridge, which was being subjected to heavy enemy ma-

chine gun fire.
"Even though several others had tried and failed in their attempts to reach the wounded officer, Corporal Technician Collins, without regard for his own per-sonal safety, made three attempts and was driven back each time by the heavy machine gun fire. He then hastily improvised a Red Cross flag and went forward under its cover to successfully evacuate the wounded officer. poral Technician Collins' determination and great courage in the face of such overwhelming odds reflects great credit upon himself and the armed forces of the Unit-

Young Collins, a former West-field high school football star, entered the army in March, 1943, and went overseas in October, 1943. He has been wounded in action twice and has already been awarded the Purple Heart with one Oak Leaf Cluster for his services in Italy, where he is still serving. He also wears the Army Good Conduct medal and the Eu-ropean Theater of War medal.

tin says.

Martin, who served as a machine-gunner with the 100th Division, was wounded by bursting artillery shells while repairing his foxhole, one side of which had caved in. It was soft, sandy territory and water was shallow. He has been in the army since November, 1942. He received his basic training at Fort Jackson, S. C., and went overseas in October, 1944.



Germany, May 19, 1945

This afternoon they told us that our mail would no longer be censored, so that means I can tell you some of the many things that I have been through since I was

October 20th, when we landed at Marseilles. We remained there about ten days before boarding a train to ride 400 miles into France, finally leaving the train driving our trucks and trace. and driving our trucks and trac-tors about 20 miles into the Vosges Mountains, I also remember Dad talking about those mountains in the other war.

We fired our first shot in combat on November 6th, and my tractor was pulling the gun that fired that opening round at the Jerries. I also helped load the gun for that first shot. It was the same old thing then, day after day, until we moved about 20 miles further north to a little place the French call "Bitchie".

I remember very well November 11 1944 (our Armistice Day back

We really started moving from there, heading 70 miles to the Rhine and on into Germany. There was plenty of action, and some narrow escapes. I ran my tractor over a German mine back in France, and it was damaged, but still in running shape. No one was with us, and I escaped without a scratch. We were back out of the lines for about two weeks before the war ended. I was lucky enough never to get a scratch, and I am truly thankful for such

We are now just waiting, pulling guard duty and hoping to get back to the States. None of us in the battery have enough points for discharge, so we can only wait

Williams was born here, and as a youth he sold peanuts and shined shoes on Montgomery streets. His first music lessons came from an aged Negro who taught him to pluck a guitar Williams had purchased for

soul, singing his heart out," wrote most of his songs while traveling. His first hit tune, "Lovesick Heart," was written in a moving car by the light of the dashboard.

His booking agent, A. V. Banford, said Williams had a "terrific memory. He would make up the words, then hum the music, and it might not take him more than 40 minutes."



### Many Gather

Dr. Smith passed away in Martin Memorial Hospital on March 14th after an illness of six months. The body lay in state in Westfield Baptist church from 1 to 3 P. M. on Thursday preceding the funeral service, during which time a steady flow of friends passed by a bier, with flowers banked across the entire platform of the church. Assist ants at the funeral estimated 5,000 people attended the services. # Air Medal Is Given To Hero's Young Son

Mrs. Bernard G. Lewis of 310 Norwood drive has returned to Charlotte from Maxwell Field, Montgomery, Ala., where her son, Bernard G., Jr., eight months of age, received the Air Medal posthumously awarded by the War department, by direction of President Truman, to her husband, Master Sergeant Lewis.

Master Sergeant Lewis, a native of Galveston, Texas, who early in World War II was stationed in the Army Air force at Morris Field, was instantly killed November 18, 1946, when an Army transport plane in which he was serving as crew chief crashed because of engine failure at a point near Craig Field, Selma, Ala.

DELAYED JUMP

Despite the increasing danger to his own safety due to constant Lewis delayed his jump in order to assist a passenger who experienced difficulty in clearing the aircraft from the rear escape hatch. The exceptional courage and exemplary devotion to duty displayed by Sergeant Lewis on this occasion are in keeping with the highest traditions of the military service.

This "meritorious achievement in aerial flight" resulted in saving the life of the passenger who was in difficulty. The other three persons in the plane, one other passenger, the pilot and the co-pilot, parachuted to safety.

In 1936 Sergeant Lewis left his home in Galveston to join the Army Air force. During the war he was stationed at jungle air bases in New Guinea three years. He had been at Maxwell Field, after his return to the United States, 14 months at the time of the fatal accident, Mrs. Lewis, the former Miss Georgia Hinson, a native of Gaston county, has spent the greater part of her life in Charlotte. She has another son, Billy Lewis, who lives with her in Charlotte, Mrs. Lewis, also makes her home withher. The baby was born approximately eight months after the death of his father.
