I am researching both the KIDD and the Paul families of Surrey County.

I know that my 4x Great Grandfathers Benjamin Kidd born about 1752 Buckingham County Virginia and Thomas Paul born about 1774 in England both settled in Surrey County in the late 1790s or early 1800's.

Benjamin's daughter Lucy Kidd married Thomas's son William Paul 29 Dec. 1818 in Surrey County there best man was Robert Kidd, Lucy's brother.

Both William and Lucy were born in Virginia he in 1792, she in 1802.

On some records I received from other Kidd researchers is a record of a marriage of Thomas Paul and Seba Walker 23 January 1821 also the best man was Robert Kidd.

My question is there any further information on this Thomas Paul, if he is my Thomas he would have been about 47 yrs old in 1821



We suggest you send a query for our journal and perhaps some of our members will be able to assist you.

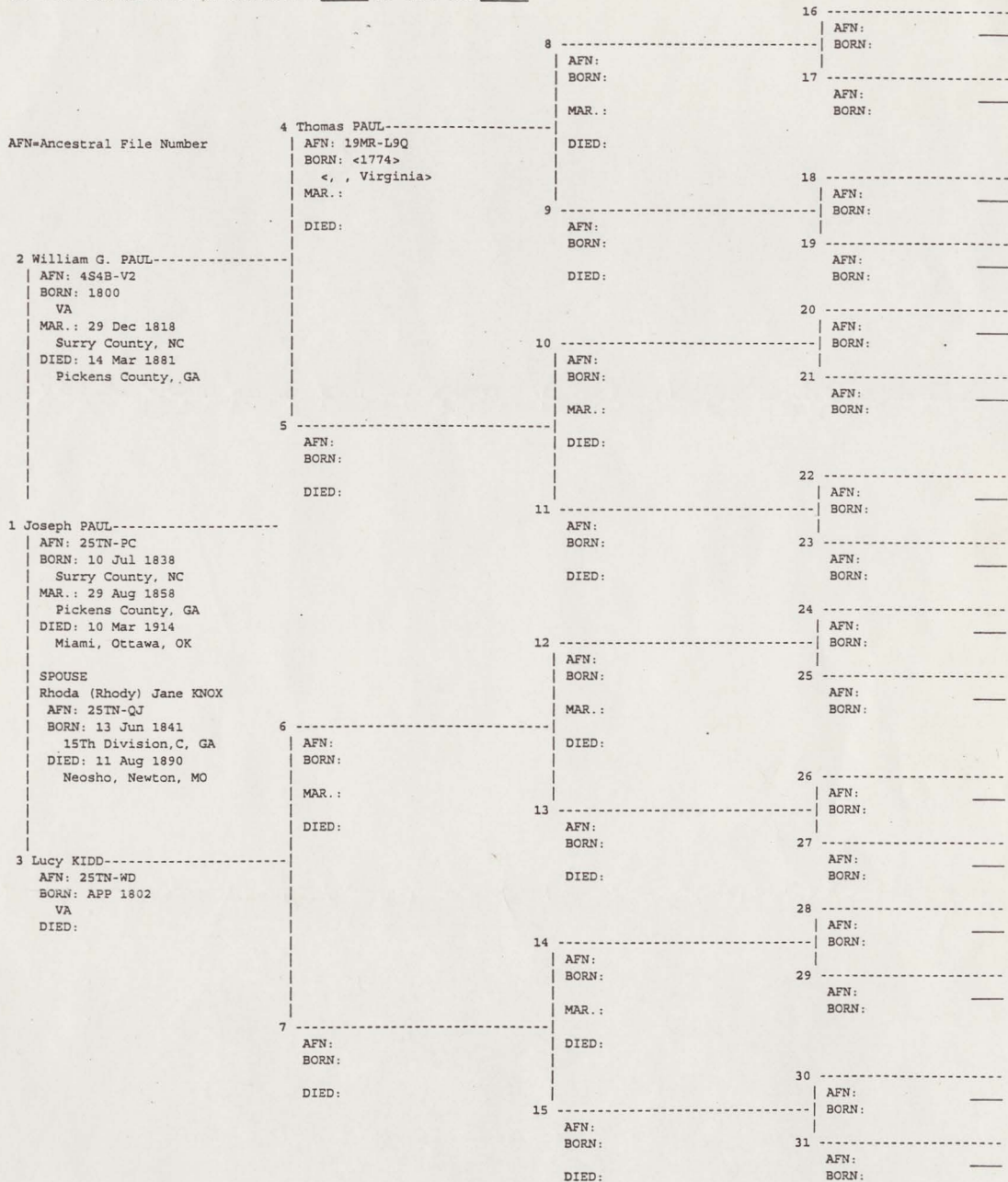

Thank you for your letter dated July 1, 2001 regarding the Paul/Kidd family. We are sorry that we have not been able to find in our files the specific things you wanted to know about these families.

We were not able to find who Lucy Kidd's parents are. And we were not able to find where in Virginia William G. and Thomas Paul came from. You might wish to submit a query to be printed in our quarterly journal. We will be happy to do so.

We are sending some miscellaneous information found in various records in Surry County on William and Thomas Paul. Thomas Paul was in Surry County as early as 1793. There is a Pauls Creek in Surry County that rises in Virginia (probably Carroll County, VA) and flows south into Surry County where it enters Stewarts Creek. It is approximately 14 miles long. We would check Carroll County for the Paul family. There is a Paul's Creek Baptist Church in Carroll County, VA. Carroll County, VA joins Surry County, NC. We did not have many Carroll County books to look at in our research room. We did look at what we had but did not find anything to tell us that the Paul's may have come from Carroll County.

We are enclosing some miscellaneous info found. We hope it will be of some help to you.

FIRST IS THOMAS PAUL I KNOW THAT HE WAS IN SURRY COUNTY FROM THE LATE 1700S TO THE EARLY 1800'S. HIS SON WILLIAM G PAUL WAS ALSO THERE UNTIL THE LATE 1830S OR EARLY 1840'S

ALSO A WILLIAM PAUL WHO I THINK MAYBE A YOUNGER BROTHER TO THOMAS.

WILLIAM G PAUL MARRIED LUCY KIDD IN DEC 1818 SHE WAS ABOUT 16 YRS OLD. HER FATHER I HAVE REASON TO BELIEVE WAS BENJAMIN KIDD ALSO OF SURRY COUNTY.


BENJAMIN KIDD HAD A WILL DATED 1847.

WHAT I AM LOOKING FOR IS ANYTHING THAT WILL TELL ME WHO THEIR RESPECTIVE WIVES WERE ARE THERE ANY DEATH RECORDS OR OBITUARIES THAT CAN TELL ANYTHING OF WHERE AND WHEN THEY DIED. I KNOW THAT WILLIAM G. PAUL DIED IN PICKENS COUNTY GEORGIA IN 1881.

ALSO ON THE 1850 CENSUS THERE IS A NATHAN PAUL AGE 28 AND FAMILY COULD THIS BE WILLIAMS SON. HE HAS A SON NAMED WILLIAM G.W. PAUL AGE 2

IF There IS ANYTHING AVAILABLE TO RESEARCH
I WOULD LIKE TO KNOW WHERE THEY END UP.

I ALSO KNOW THAT BOTH FAMILIES CAME FROM
VIRGINIA ORIGINALLY. I HAVE SEVERAL QUERIES
OUT TO VARIOUS COUNTIES THERE.



Thank you for your letter dated January 30, 2002 regarding the Paul/Kidd families. We are sorry that we still do not have further information on this family. Lucy Kidd Paul was not named in the will of Benjamin Kidd dated 1847. Nathan Paul in 1850 was in the South Division of Surry County which later became Yadkin County, NC. Death records were not kept in NC until 1913.

We will place a query in our journal and hope you get some response. We wish that we could help you more with your questions.
