# THE DUTIES OF THE PASTOR

# INTRODUCTION

- A. The office of Pastor is referred to by four similar terms in the New Testament.
  - 1. "Overseer" (Greek: episkopos) = Watchman, Superintendent, Administrator
  - 2. "Teacher" (Greek: didáskalos) = Instructor, Teacher of Doctrine
  - 3. "Elder" (Greek: presbyteros) = Leader, Vision-Caster
  - 4. "Shepherd" (Greek: poimén) = One who ensures that needs are met
- B. Biblical evidence links the office "elders" and "overseers" (pastors or "bishops") as one in the same office; and the office of "deacon" as a second, separate office.
  - 1. In Titus 1:5, Paul says that he left Titus in Crete to "appoint elders (*presbyteros*) in every town." Then, without any break in subject-matter, Paul begins using the term "overseers (*episkopos*)" in Titus 1:7. The clear implication is that "elders" and "overseers" are synonyms used for the same office.
  - 2. In Acts 20:17, Paul meets with "the elders of the (Ephesian) church." In verse 28 of that same chapter, Paul says that the Holy Spirit has "made [these elders] overseers, to care for the church of God." Clearly, Paul made no distinction between "elder" and "overseer."
  - 3. The qualifications of "overseers" (pastors) in 1 Timothy 3:1-8 are almost identical with the qualifications of "elders" in Titus 1:5-9. And there is an obvious, unmistakable emphasis on the role of guarding and teaching sound doctrine in both.
  - 4. 1 Timothy 3:1-13 gives separate sections for the qualifications of "overseers" (pastors) and "deacons" that are clearly delineated.
  - 5. In the introduction to his letter to the Philippian church, Paul greets "all the saints in Christ Jesus who are at Philippi, with the overseers and deacons." Another demarcation between "overseer" and "deacon."

# THREE DUTIES OF A PASTOR

# 1.) GENERAL SUPERINTENDENT OF THE CHURCH

- A. Acts 20:28 Pay careful attention to yourselves and to all the flock, in which the Holy Spirit has made you overseers, to care for the church of God, which he obtained with his own blood.
  - 1. Indicates a mutual superintendence among the elders (= bishops/pastors) and the entire *flock* (the entire group of believers).
  - 2. has made you indicates the supreme call of the Holy Spirit to the office. Above everything, it was the Holy Spirit, not the Church, placing these men into office.
- B. 1 Tim. 3:5 If someone does not know how to manage his own household, how will he care for God's church?
  - 1. The verb translated manage means "to lead, to rule."
  - 2. In 1 Tim. 3:3, the pastor is said to rule over his family well, and that manner of ruling is understood in verse five.
  - 3. The word which is translated *care for* means "to show concern over." This word indicates a general leadership and care of the church of God (not simply preaching) in similar ways as a father gives general leadership and care of his home.

- C. 1 Corinthians 12:28 God has appointed in the church first apostles, second prophets, third teachers, then miracles, then gifts of healing, helping, administrating, and various kinds of tongues.
  - 1. Paul listed seven appointments that God had made in the church.
    - a. It appears that he listed the first three of these in order of importance, and would best be described as "offices."
    - b. But the last five are listed without indicating any priority and should best be understood as "gifts."
  - 2. Apostles were those who had be personally called into Gospel ministry by Jesus Himself; and also had seen Jesus personally after His resurrection and could therefore serve as an eyewitness to His resurrection. No one alive today can qualify for this office.
  - 3. *Prophets* in the New Testament, like their counterparts in the Old Testament, were instruments of special revelation from God. They were listed beside apostles because their office was also foundational to the church in that, through them, God gave new and fully revelation; much of which became the written New Testament.
  - 4. *Teachers* are of third importance. In the New Testament, teachers were like Jewish rabbis. They studied the Scriptures and taught the church sound doctrine. In Ephesians 4:11 Paul associated the office of teacher with that of pastor. This office is not an office of special revelation, but an office of interpreting special revelation correctly and presenting it clearly so as to preclude any false doctrine.
- D. Hebrews 13:17 Obey your leaders and submit to them, for they are keeping watch over your souls, as those who will have to give an account. Let them do this with joy and not with groaning, for that would be of no advantage to you.
  - 1. There is an inherent authority in the office of pastor/overseer, though the authority seems to be tied to the Word of God and not the office itself, since the overseers must also *give an account*. In other words, congregants ought to *obey* and *submit* because God says so, not because the pastor/overseer deserves this.
  - 2. The reason for this prescribed submission? for they are keeping watch (to abstain totally from sleep, to watch, wake, be awake) over your souls.
    - a. The pastor must be watchful and constantly attentive to spiritual things
    - b. He is the under-shepherd who should "give his life for the sheep" (Jn. 10:14)
  - 3. Those that do not submit to godly leadership...
    - a. Injure themselves by resisting God (and this is certainly of no advantage to you).
    - b. Burden their leaders and syphon the joy from their work of keeping watch.

# II.) GUARDIAN AND TEACHER OF SOUND DOCTRINE

- A. A distinct function of pastors or elders is teaching
  - 1. 1 Timothy 3:2 Therefore an overseer must be...able to teach...
  - 2. 1 Timothy 5:17 Let the elders who rule well be considered worthy of double honor, especially those who labor in preaching and teaching.
  - 3. Titus 1:9 He (an elder/overseer) must hold firm to the trustworthy word as taught, so that he may be able to give instruction in sound doctrine and also to rebuke those who contradict it. This refers to both teaching, counseling, and exhortation.
- B. They are to teach the Word, not their opinions
  - 1. 2 Tim. 4:2 *Preach the word; be ready in season and out of season; reprove, rebuke, and exhort, with complete patience and teaching.*

- 2. Titus 3:9 But avoid foolish controversies, genealogies, dissensions, and quarrels about the law, for they are unprofitable and worthless.
- C. Titus 1:9 He must hold firm to the trustworthy word as taught, so that he may be able to give instruction in sound doctrine and also to rebuke those who contradict it.
  - 1. The work of the pastor is designated as holding firm to the faithful or trustworthy word according to the long-established and accepted doctrine.
  - 2. The pastor is described as a man who must be able to refute false doctrine and exhort or comfort through the teaching of sound doctrine, even those who are opposed to that doctrine.
  - 3. He is a man who must be able and willing to reprove (reprimand, admonish, or rebuke) those who speak in contradiction to sound doctrine.
- D. Acts 20:28 Pay careful attention to yourselves and to all the flock, in which the Holy Spirit has made you overseers, to care for the church of God, which he obtained with his own blood.
  - 1. Their duty was the general care of the flock. This general care is accomplished primarily, though not exclusively, through the teaching the Word of God.
  - 2. While "elders" or pastors must be able to teach, not all will do this as their primary ministry. There seems to be a distinction made in favor of those elders whose primary responsibilities are carried out through preaching and teaching. 1 Tim. 5:17 Let the elders who rule well be considered worthy of double honor, especially those who labor in preaching and teaching.
- E. Ephesians 4:11-13 And he gave the apostles, the prophets, the evangelists, the shepherds and teachers, to equip the saints for the work of ministry, for building up the body of Christ, until we all attain to the unity of the faith and of the knowledge of the Son of God, to mature manhood, to the measure of the stature of the fullness of Christ.
  - 1. The Lord Jesus gave pastors and teachers to the Church for the purpose of maturing the Church. Their ability and primary function is to preach and teach.
  - 2. These can do the best job of preaching and teaching only if there are others (non-teaching Pastors and/or Deacons) in the local congregation who fulfill the other functions, which meet the variety of needs of the flock.
    - a. In 1 Thessalonians 5:12, Paul asks that those who labor and rule in the Lord must be loved especially for their work.
    - b. In Romans 12:6–8, Paul gives the different ministries for which the gifts are given and one of them is that of teaching.
    - c. In Hebrews 13:7, 17, 24, they are called "leaders." Thus the pastors or bishops must have leadership gifts.
    - d. In Acts 15:6, we find that the Apostles AND the elders/pastors gathered together to discuss the teaching of those who taught the heresy of the Pharisees, demanding that believers be circumcised.
    - e. In Acts 21:18, when Paul and others were received in Jerusalem, it was not only by James but also by all the elders.
    - f. The cooperation of the elders with the apostles is also indicated in 1 Timothy 4:14.

# III.) GIVER AND DIRECTOR OF CONGREGATIONAL CARE

- A. While the (Senior) Pastor is ultimately responsible for ensuring that ministry needs are met, no one person is capable of meeting every need in a congregation.
  - 1. The Pastor must "lead by example" in giving pastoral care.
  - 2. But He must guard against "bottlenecking" pastoral care by talking it alone. One of the major responsibilities of a Pastor is to ENSURE the needs of the flock are met by training other

believers in how to care for one another. Ephesians 4:11-12 – He Himself (Christ Jesus) gave some to be...pastors and teachers, for the equipping of the saints (the general congregation) for the work of ministry (meeting congregational needs).

- B. Pastoral Care includes visiting the sick. James 5:14 Is anyone among you sick? Let him call for the elders of the church, and let them pray over him, anointing him with oil in the name of the Lord.
- C. Pastoral Care includes being devoted to the welfare of others. This is the meaning of hospitable (see 1 Timothy 3:2 Therefore an overseer must be...hospitable...; and Titus 1:7-8 For an overseer, as God's steward, must be...hospitable...)
  - 1. This means he is ready and willing to make changes in his schedule to meet needs that arise.
  - 2. This means that he has and expresses a genuine care for the congregation.
    - a. The CAN be expressed in social visits; but it is certainly not limited to social visits. (Social visits are defined here as visits not designed to meet a particular need, but rather to just "checkup" on people.)
    - b. No case can be made from Scripture that social visitation is a primary responsibility of a Pastor. Rather (in Acts especially), fellowshipping "from house to house" seems to be the nature outcome of the congregants loving one another.
- D. Pastoral Care includes leading, feeding, and protecting the flock of God. 1 Peter 5:2-3 Shepherd the flock of God that is among you, exercising oversight, not under compulsion, but willingly, as God would have you; not for shameful gain, but eagerly; not domineering over those in your charge, but being examples to the flock.
  - 1. The command is Shepherd the flock.
    - a. Elsewhere in the New Testament, that word is translate an equal number of times as "feed" and "rule."
    - b. However, the context here seems to emphasize leadership since the opening phrase is qualified by *exercising oversight*.
  - 2. Of major concerning in this passage is the issue of motivation.
    - a. *not under compulsion, but willingly* The pastor should DESIRE to fulfill this calling. If there is no desire, then perhaps there was never a call to it.
    - b. *not for shameful gain, but eagerly* The pastor's motivation should never be to make "easy money." Such a thought pattern shows a selfish heart that will not *shepherd the flock* when doing so becomes difficult.
    - c. not domineering over those in your charge, but being examples The pastor should have heart that always desires what is best for the flock. He should not be domineering in the sense of setting up his own "kingdom," but should rather live as an example of Christ-likeness in order to lead the flock to maturity.
  - 3. Pastoring takes in all the activities of shepherding.
    - a. A congregation that has weak leadership or a lack of direction will be easy prey for the Enemy.
    - b. A congregation that is not well-fed (spiritually) will be easily led astray into false doctrine, and will be unprepared for victory in spiritual warfare.

January Business Meeting

Westfield Baptist Church held its regular monthly business meeting on January 8, 2014. There were 52 members present. The meeting was called to order by Pastor Joel Stephens.

Minutes from the December 11, 2013 monthly business meeting were read and approved by unanimous consent.

# Van Committee

Chuck Chilton reported that we'd been having a lot of trouble with the church's red van and that the committee had been looking for a new van. He gave details of a 2012 Ford E350 15-passenger van that Joe Cook had found. He presented a motion that the congregation authorize the Van Committee to purchase this van for \$23,000 or less, which did not require a second. After a brief discussion, the motion passed. It would be determined at a later date if the red van would be sold.

# **Finance**

Mickey Love asked if there were any questions concerning the financial statement; there were none.

#### **Deacons**

Mark Oakley, representing the Deacons and the Constitution Committee, directed everyone's attention to a hand-out outlining a proposed constitutional revision. (A detailed copy is on file.) He asked everyone to read and prayerfully consider the proposed revision for the next month and be prepared to discuss it further at the February business meeting. Approval to accept the revision would then be voted upon Sunday, the 16<sup>th</sup> at the close of both services.

There being no other committee reports, old or new business, a motion to adjourn was made and seconded. The meeting was adjourned with prayer.

SUBJ: Proposed Change to the By-Laws of Westfield Baptist Church

Dear Congregation:

As I'm sure you are all aware, there is an attack on marriage in our nation. The overstepping of a federal judge in any given state seems an almost weekly occurrence. A recent article in the *Winston-Salem Journal* makes it clear that the 4<sup>th</sup> Circuit Court of Appeals, which covers the Carolinas, West Virginia, Virginia and Maryland, will hear potentially ground-breaking marriage cases in the coming months.. In other words, the Marriage Amendment passed by the NC voters in May 2012 may not survive to see its second anniversary.

Most of this recent judicial onslaught is the direct product of the Supreme Court's decision last year to declare parts of the federal Defense of Marriage Act unconstitutional on the grounds of discrimination. This decision has given federal judges in lower courts the ground they desired to declare many of the individual state's efforts to protect marriage to be in violation of the federal constitution. The Supreme Court will most likely rule in at least one or perhaps three cases concerning the definition of marriage in May or June. If the high Court continues to ignore the rights of the states and bow to the changing tides of public opinion, then same-gender marriage will likely be legal in all 50 states by the end of this year.

If this happens, it is more than probable that churches like ours will be faced with difficult challenges. In short, if I refuse to do a same-gender wedding, or if we refuse to allow our facilities to be used for such a "ceremony", then our church could be sued on the grounds of discrimination. Frankly, this seems inevitable.

But perhaps there are some steps we can take to protect ourselves somewhat. The Supreme Court still seems to value the Church's "religious freedom" sufficiently to protect us so long as our stance on marriage is clearly stated as "a religious conviction" in our governing documents. Therefore, I recently presented the attached suggested changes to your Deacons and Constitution Committee for their consideration. Both whole-hearted supported them.

I am fully aware that we have just concluded a Constitutional change. It is not our usual practice to bring so much change so close together. But with the decisions of the Supreme Court looming on the horizon, I do not feel that this can wait. Any legal challenge will most likely come directly on the heels of any decision that the high Court gives later this year while emotions are high and while the opposition has the most momentum.

The language in the proposed changes comes almost entirely from the recommendations of the Alliance Defending Freedom's attorneys. The Alliance Defending Freedom (formerly the Alliance Defense Fund) has been a solid conservative voice in the judicial processes of our country for years. And they have a proven track record of helping churches and other faith-based non-profits navigate these dark waters. Check them out on the web at http://www.alliancedefendingfreedom.org

These inclusions - if approved - will NOT prevent us from being sued. BUT they may go a long way to preventing it and/or giving us a leg to stand on if/when we are sued.

As always, your prayer input is welcome. However, I would ask you to be mindful that the language given by the ADF is strategically crafted by those who have legal experience in creating such documents. In other words, I think we need to be careful how much we tinker with it lest we unravel the protection the language offers.

I am saddened beyond description that we have arrived at this place in the country that I love. But I/we cannot allow my/our disappointment and discouragement to blind us to the need to protect our congregation (as much as possible) in these troubling times. Please prayerfully consider adopting these revisions in order to do so.

# Proposed Change to the WBC's By-Laws

The Deacons, with the advice and consent of the Constitution Committee, move the adoption of the following proposed changes to Westfield Baptist Church's By-Laws. We propose to include a new Article to our By-Laws clarifying our congregation's religious convictions concerning the social issues facing the Church today.

# ARTICLE V - STATEMENTS OF RELIGIOUS CONVICTIONS

The following statements seek to clarify with further detail certain religious convictions already alluded to in our Church Covenant.

# Section 1 - Statement of Biblical Authority

The Bible itself, as the inspired and infallible Word of God that speaks with final authority concerning truth, morality, and the proper conduct of mankind, is the sole and final source of all that we believe. For purposes of church doctrine, practice, policy, and discipline, the membership of Westfield Baptist Church – under the leadership of the pastors and deacons – shall be the church's final interpretive authority on the Bible's meaning and application.

# Section 2 – Statement of Faith and Doctrine.

While we recognize that no statement of faith written by mankind could exhaust the extent of our faith and convictions, Westfield Baptist Church affirms the Baptist Faith & Message as adopted by the Southern Baptist Convention as the primary declaration of our religious doctrines which are ultimately derived from the Holy Bible.

# Section 3 – Statement of Marriage and Sexuality.

We believe that the term "marriage" has only one meaning and that is marriage sanctioned by God which joins one man and one woman in a single, exclusive union, as delineated in Scripture. We believe that God intends sexual intimacy to only occur between a man and a woman who are married to each other. We believe that God has commanded that no intimate sexual activity be engaged in outside of a marriage between a man and a woman.

We believe that any form of sexual immorality, such as but not limited to adultery, fornication, homosexuality, incest, pornography or any attempt to change one's gender, or disagreement with one's biological gender, is sinful and offensive to God.

We believe that in order to preserve the function and integrity of the church as the local Body of Christ, and to provide a biblical role model to the church members and the community, it is imperative that all persons employed by the church in any capacity, or who serve as volunteers, should abide by and agree to this Statement on Marriage and Sexuality and conduct themselves accordingly.

We believe that God offers redemption and restoration to all who confess and forsake their sin, seeking His mercy and forgiveness through Jesus Christ.

We believe that every person must be afforded compassion, love, kindness, respect, and dignity. Hateful and harassing behavior or attitudes directed toward any individual are to be repudiated and are not in accord with Scripture nor the doctrines of Westfield Baptist Church.

May Business Meeting

He then made a motion to this effect, which did not require a second. The motion passed.

### **Building Committee**

Mark Oakley referred to the "Building Committee's Project Update to the Church" handout that was made available to everyone. A copy of this report is on file in the church office. He noted that the septic system project at the parsonage had been delayed due to all the wet weather. He, then, presented a motion to replace one of the two HVAC units that heat the fellowship hall. This one unit stopped working long ago. The cost to replace the unit is estimated at \$12,000, which will be taken from the Building Fund with any unused portion remaining in that fund. The motion came from a standing committee, which did not require a second. The question was asked whether it would be more feasible to purchase one larger unit to replace the two smaller units that were previously installed to heat the fellowship hall. After some discussion, the motion was tabled to allow Mickey Arrington time to call a representative from Pilot Mechanical. The motion to table was seconded and approved, and Mickey left the meeting to make the phone call.

While waiting for him to return, Mark once again referred to the Building Committee's report and presented a second motion that \$1600 be set aside from the Building Fund to remodel the downstairs bathrooms in the east educational wing (old education building), as well as replace the two exterior doors to that building with new, easy-exit doors that have a panic bar that locks from the outside, but allows anyone inside to exit quickly and easily. It was noted that locking the existing doors while services are taking place does not meet fire code. The possibility of selling the existing doors was suggested. Again, when both projects are complete, any unused funds will remain in the Building Fund. The motion did not require a second and, after a brief discussion, passed.

Mark, then, directed everyone's attention to the third item on the report, which has been moved up to "high priority" due to fire hazard concerns. It is the hope that this item will be presented at the February business meeting. Quotes are being obtained to re-wire the sanctuary and old education building. The report indicates that this will not require new wiring, outlets, fixtures, etc., but Mark asked that the word "wiring" be marked out and clarified that this meant any additional wiring. He reiterated that all the projects on the report are a result of the responses received on the survey given to church members many months ago. These were all items of concern that should be addressed before the church begins a new building program.

### **Finance**

Mickey Love reviewed the financial statement and asked if there were any questions; there were none.

### **Audio-Visual**

A copy of the proposal with details is on file in the church office.

Mickey Arrington returned to the meeting, stating that he was unable to reach his contact. Pastor Joel stated that the original motion could be brought back to the floor as presented or it could be amended. Grace Stewart moved that the motion be voted upon, which would then be a motion to call to question and end debate on the motion presented. This required a second and 2/3 majority vote. The vote to call to question and cease debate passed.

The original motion to replace the HVAC unit as presented was then voted on and passed.

### **New Business**

#### **COMMITTEE UPDATES**

Associate Pastor, Kendall Yarboro, presented a slide show presentation and details of the upcoming short-term youth mission trip to Staten Island, N. Y. The dates for this trip are July 2<sup>nd</sup>-9<sup>th</sup> with an organization called Score Domestic Missions. The cost per participant is expected to be \$600, with \$300 being provided by the attendee and \$300 coming from the church budget. Approximately \$4800 is the cost from the budget for 15 participants, but after fundraising events, the cost will be roughly \$2458. To eliminate the cost of flying, the church vans will depart from the church July 2<sup>nd</sup>, make the 9-hour drive to N. Y., and then return on July 9<sup>th</sup> after spending one night on the return trip home. Pastor Kendall then made a motion that the church approve taking \$300 per participant from the budget line item, which was seconded. The floor was open for discussion and the question was asked if the trip was limited to 15 individuals, to which Pastor Kendall replied it was not. Two adult chaperones per 7 youth are required by Score Domestic Missions. The parents of youth will be given the first opportunity to act as chaperones, with other willing adults being given the opportunity, if necessary. The motion was approved.

### **Building Committee**

Mickey Arrington updated the group on the issue of re-wiring that the committee had been tasked with at the December business meeting. He reported that, after several weeks, the first electrician that had come to inspect the church's wiring and give an estimate said he was months behind in his work and would be unable to do the job. A second electrician, J. W. Bowman, was recommended by Pilot Mechanical. This gentleman has already done work for our church and comes highly recommended. Mickey met with him and, together, inspected every part of our electrical system. Mr. Bowman stated that our existing wiring was entirely safe, well-insulated, and did not need upgrading to be any safer. Two new outlets, however, will be required for installation of the new sound system, but this work can be done by members of the Building/Grounds Committee. After some discussion, the Building Committee was given the OK to move on to the next project without spending unnecessary money on re-wiring.

### **Finance**

Chairperson, Ruth Chilton, stated that the treasurer, Suzette Jessup, would be presenting the treasurer's report going forward. Suzette referred to copies of the new financial statement, reporting that the accounting option of the Power Church software had been set up and used since the beginning of the year. It has taken several months to get the financial information into the system and the proper reports created, so the decision was made to introduce the new financial reports with the start of the church year beginning in October. The payroll option of Power Church will be put in place beginning in January, thereby utilizing Power Church in its entirety. She reviewed the financial reports line by line and referred to a notebook explaining the funds in greater detail that will be available at each business meeting. This notebook will be placed in the church office after business meetings.

After a brief discussion, Mickey Love commented that, although contributions have been managed by the church secretary in Power Church for 6-7 years, the accounting option has not been used until this year. Doing so will save time and duplicate work going forward.

Lyndsey Haywood commented that it is extremely helpful to the counters when everyone uses the envelopes that have been assigned, as each family has been issued a number that is already in the Power Church system.

Mickey Love briefly commented that he and B. J. had traveled to Boone to work with the distribution of the shoeboxes, reporting that 850,000 boxes had been collected at this one drop-off site. Overall, approximately 11 million shoeboxes were delivered through Operation Christmas Child.

### **New Business**

F. Morton, pastor of the church assisted by Rev. R. W. George, Rev. Joe Hall and J. T. Smith.
