Thank you for your letter dated August 3, 2002 regarding John Holman/Holeman and Caleb Baker. We have enclosed the copy of the marriage bond for John Holman and Nancy Alnutt found in Surry County. We are sorry that there is not much info on the bond and not a very good copy.

Only other early Holeman marriage found in Surry is Absalom Holeman who married Hannah Hudspeath. Bond is dated 27 Jan 1794 (A-2825).

We were unable to find a marriage record for Caleb Baker in Surry County. There is a will in Surry County for Henry Baker dated 1788 that lists a son Caleb Baker. We have enclosed a copy of the abstract. There are Holcomb families in Yadkin County, NC as well as Surry County today.

There is a James and Lucy Cook Holeman in the Huntsville area of NC (now Yadkin County). She is the daughter of William Cook whose will is in Surry County dated 1812 and he also names a daughter Mary (Cook) Holeman.

There is a deed in Surry County (D:50) dated 15 Sep 1786 from James Sanders, Sr. to Daniel Holeman and wife Nanny Sanders, otherwise Holeman, for love said Sanders has for his daughter Nanny and the heirs of her body....
