BY-LAWS AND CONSTITUTION

PREAMBLE

WE, THE MEMBERS OF THE LUCY HANES CHATHAM CLUB #1, DESIRING TO UPHOLD HIGH IDEALS AND TO PROMOTE FRIENDLINESS AMONG THE GIRLS OF THE CHATHAM MANUFACTURING COMPANY DO HEREBY ADOPT THIS CONSTITUTION FOR THE CLUB.

BY-LAWS

1. THE PRESIDENT SHALL PRESIDE OVER ALL MEETINGS OF THE CLUB AND ALL EXECUTIVE COMMITTEE MEETINGS. SHE SHALL APPOINT ALL COMMITTEES AS MAY BE NECESSARY TO CONDUCT THE BUSINESS OF THE ORGANIZATION OF HER DISCRETION.
2. THE VICE-PRESIDENT SHALL PERFORM THE DUTIES OF THE PRESIDENT IN HER ABSENCE AND SHALL BE PROGRAM CHAIRMAN. SHE SHALL WORK WITH THE HOSTESSES EACH MONTH IN PLANNING THE PROGRAM.
3. THE SECRETARY SHALL KEEP A PERMANENT RECORD OF THE PROCEEDINGS OF THE MEETING AND REPORT IT TO THE BLANKETEER. SHE SHALL ALSO KEEP A ROLL OF THE MEMBERS, WITH FULL NAMES AND ADDRESSES. SHE SHALL ALSO SERVE AS SECRETARY OF THE EXECUTIVE COMMITTEE.
4. THE ASSISTANT SECRETARY SHALL SERVE IN THE ABSENCE OF THE SECRETARY AND SHALL KEEP A SCRAPBOOK OF ALL CLIPPINGS AND PICTURES OF INTEREST TO THE CLUB. SHE SHALL ALSO BE IN CHARGE OF THE CAMERA.

5. THE TREASURER SHALL COLLECT ALL DUES AND DISBURSE ALL FUNDS UPON APPROVAL OF THE PRESIDENT. SHE SHALL ALSO MAKE A MONTHLY FINANCIAL REPORT TO THE CLUB.
6. THE ASSISTANT TREASURER SHALL ASSIST THE TREASURER IN COLLECTION OF DUES AND SERVE IN THE ABSENCE OF THE TREASURER. SHE SHALL ALSO COLLECT ALL SUPPER DUES AND DISBURSE SAME.
7. THE CHAPLAIN SHALL BE RESPONSIBLE FOR THE DEVOTIONALS OF EACH CLUB MEETING.
8. THE EXECUTIVE COMMITTEE SHALL TAKE ACTION SHOULD AN UNEXPECTED CRISIS ARISE.
9. THE WELFARE COMMITTEE SHALL KEEP IN TOUCH WITH SICK MEMBERS AND ASSIST WITH WELFARE WORK. THEY SHALL SEND FLOWERS TO MEMBERS OR HELP IN WHATEVER WAY NEEDED IN CASE OF DEATH IN THE IMMEDIATE FAMILY.
10. THE HOSTESSES SHALL BE RESPONSIBLE FOR THE MEETING PLACE, MENUS, AND DECORATIONS FOR THE MONTH IN WHICH THEY SERVE.
11. THE MEMBERSHIP COMMITTEE SHALL BE RESPONSIBLE FOR SECURING NEW MEMBERS AND CONTACTING ABSENTEES.
12. MEMBERS, AFTER HAVING RECEIVED RECOGNITION FROM THE PRESIDENT SHALL HAVE THE RIGHT TO SPEECH AT ALL MEETINGS OF THE CLUB AND SHALL HAVE THE RIGHT AT ANY TIME TO

12. MAKE SUGGESTIONS TO THE CLUB CONCERNING QUESTIONS OF INTEREST.

ARTICLE I - NAME

SECTION 1. THE NAME OF THE CLUB SHALL BE THE LUCY HANES CLUB #1

ARTICLE II - PURPOSE

SECTION 1. TO PROMOTE A MORE FRIENDLY FEELING AMONG THE GIRLS OF CHATHAM MANUFACTURING COMPANY.

SECTION 2. TO PROMOTE SPIRITUAL, MENTAL, PHYSICAL AND SOCIAL DEVELOPMENT OF ITS MEMBERS.

ARTICLE III - MEMBERSHIP

SECTION 1. ALL GIRLS EMPLOYED BY CHATHAM MANUFACTURING COMPANY ARE ELIGIBLE FOR MEMBERSHIP.

SECTION 2. MEMBERS OF THE CLUB LEAVING THE COMPANY IN GOOD STANDING MAY RETAIN THEIR MEMBERSHIP IN SAID CLUB.

SECTION 3. NON PAYMENT OF DUES BY OCTOBER FIRST AND FAILURE TO TAKE PART IN THE ORGANIZATION'S WORK SHALL CONSTITUTE A FORFEITURE OF MEMBERSHIP.

ARTICLE IV - COMMITTEES

SECTION 1. THE OFFICERS OF THIS ORGANIZATION SHALL BE: PRESIDENT, VICE-PRESIDENT, SECRETARY, ASSISTANT SECRETARY, TREASURER, ASSISTANT TREASURER AND CHAPLAIN.

SECTION 2. THE STANDING COMMITTEES OF THIS ORGANIZATION SHALL BE: EXECUTIVE COMMITTEE, WELFARE, PROGRAM, WAYS AND MEANS, MEMBERSHIP, YEAR BOOK AND SCRAP BOOK.

SECTION 3. THE EXECUTIVE COMMITTEE SHALL BE COMPOSED OF THE PRESIDENT, VICE-PRESIDENT, SECRETARY, ASSISTANT SECRETARY, TREASURER, ASSISTANT TREASURER AND CHAPLAIN.

ARTICLE V - NOMINATIONS AND ELECTIONS

SECTION 1. AT THE OCTOBER MEETING A COMMITTEE OF THREE SHALL BE APPOINTED BY THE PRESIDENT TO SERVE AS A NOMINATING COMMITTEE. THE COMMITTEE SHALL PRESENT A LIST OF TWO CANDIDATES FOR EACH OFFICE FOR ELECTION AT THE NOVEMBER MEETING.

SECTION 2. ALL OFFICERS SHALL BE ELECTED BY WRITTEN BALLOT. A MAJORITY OF THOSE PRESENT ENTITLED TO VOTE AND VOTING SHALL CONSTITUTE AN ELECTION.

SECTION 3. THE INSTALLATION OF OFFICERS SHALL BE IN JANUARY.

ARTICLE VI - MEETINGS AND DUES

SECTION 1. MEETINGS SHALL BE HELD AT THE DISCRETION OF SAID CLUB.

SECTION 2. THE ANNUAL MEMBERSHIP DUES SHALL BE THREE DOLLARS (\$3.00).

SECTION 3. THE FISCAL YEAR SHALL BEGIN IN JANUARY. ANY MEMBER FAILING TO PAY DUES BY OCTOBER FIRST, AFTER HAVING RECEIVED TWO NOTICES FROM THE TREASURER, SHALL BE CONSIDERED AS HAVING VOLUNTARILY WITHDRAWN FROM THE ORGANIZATION, AND HER NAME SHALL BE DROPPED FROM THE ROLL.

ARTICLE VII - AMENDMENTS

SECTION 1. THE CONSTITUTION OF THE ORGANIZATION MAY BE AMENDED BY A VOTE OF TWO-THIRDS OF THE MEMBERS PRESENT, PROVIDED THAT NOTICE OF THE PROPOSED AMENDMENT HAS PREVIOUSLY BEEN POSTED.
