One would think with a name like Emanuel (Amanuel, Imanuel, Manuel) that the records would not be too elusive but even though I have been searching since the 1960's, I have no clue as to his parentage, his sibling nor where they came from to Surry/Wilkes counties, North Carolina. Is he on a Passenger List and I have missed it or was he born in America? Hope someone out there can give all the information I lack! ©

Emanuel was in Surry Co. as early as 1774, when he was on the Tax List as paying 1 poll (himself) and again in 1777, the same year Wilkes Co. was formed from Surry Co. He was listed in Benjamin CLEVE-LAND'S District with 2 improvements, 7 cattle, 5 horses, 10 pounds, 5 shillings.

On 29 June 1778 he was granted Land Entry # 223 for 100 acres (another source says 450 acres), including improvements on Roaring River, where he now lives. On Sep. 5, 1778 he is listed with entry #313 450 acres on Middle Fork of Roaring River adjoining Widow Alexander in Benjamin Cleveland's District, Roaring River but his name was marked out with John Allen WOODRUFF's name written in (another ancestor of mine) Source: Entry Bk. 1778- 81. But another source says it was 200 acres, take your pick! In 1779 he received another Grant for 70 acres on Roarin River. 25 Mar 1780 Emanuel was given Grant #1687 Or #152, another source for 440 acres on middle fork of Roarin River.

In 1782 Emanuel was taxed and paid in Wilkes Co. on 170 acres; 4 horses and 6 cattle, 1 slave; in 1784 Tax List 424 acres, 1 poll (himself); in 1785, in Capt. Samuel JOHNSON's District, 2 polls. This is also the year that the law was made that you were excused from paying poll taxes when you reached age 60 yrs. Same in 1786. That year he was on a Road Jury from Iron Works to N. Fork of Roarin' River to S. Fork. In 1787 he was on Tax List for 135 acres and 2 poll taxes, 1 black, age 21-50.

Wilkes County Court Minutes by Ruby Absher 1778-1788, besides relating the above Land Grants and Jury Duty, also shows that in 1787 Amanuel was on the Jury for trials in July 1788 of Jms. REYNOLDS vs. John HALL, Sr. & Edmund DENNY; also Reubin WHITE vs. Wm. MCGILL; Thos. CALLOWAY vs. Thos. TERRY; Daniel HULL vs. Jn. TURNBULL. 5 of reported 7 trials listed as Emanuel serving on them.

In 1788 2 polls on 75 a. or another source says 135 a. but he also received another 60-acre grant and that might be the reason for 135 acres. We copied a couple of his land sales (to Edmond BOOZ and James WEBB). In 1789 2 polls on 195 a. (So, why is he still paying poll tax – is that for Emanuel who has probably reached the age of 60 yrs. and no longer has to pay a poll on himself? Maybe he isn't aware of the law or is there another slave or adult living with him and working on farm?); in 1792 taxes 1 poll on 335 acres according to Tax List, taxes same in 1793/4/5; then Emanuel is gone and Mary HAMPTON ROSE in 1796 paid 1 poll and listed with 250 a.; in 1797 she listed 350 a. and no polls.

The only Census I have for Emanuel is in Capt. JOHNSON's Dist., taken July 7, 1787; 1 WM 21-60 (Was this the Joseph that signed with Mary when she sold some of property after Emanuel's death; maybe had his share before this first census? I have never found him in the records before or since.) 1 WM under 21 over 60 (Emanuel) 4 WF, Elizabeth not yet born?) 1 BP 21-60. Had Emanuel been married before and had Joseph; he seems to have been considerably older than Mary.

Following is the Last Will and Testament of Emanuel Rose, deceased, May Term 1796. 3 May 1796 Mary received Letter of Administration of Emanuel's Estate on the oath of John HAMMON, evidently Emanuel deceased before this date. In Aug. 1796 Mary taxed 1 poll on 250 acres. Mary married John HALL, Sr. and declined to administer Emanuel's estate, thus Spencer ADAMS was appointed to administer the Estate. Before this Mary sold a piece of property and Joseph ROSE signed as witness; no indication as to relationship if any. THE WILL...

"In the name of God Amen, I Emanuel Rose of Wilkes County and North Carolina, being in perfect mind and memory but somewhat afflicted in body, calling to mind the Mortality of man and that it was appointed once for all to die, I make and ordain this my last Will and Testament. First of all, I recommend my sole to God that gave it and my body to the Earth to be Buried in a decent Christian Burial at the discretion of my Executors nothing doubting but I shall Receive it again at the last Resurrection by the almighty powers of God.

And as touching this worldly Estate which it has please God to bless me with I give demise and dispose of in the following manner and form: to wit first I leave to my beloved wife Mary Rose my hole estate during her natural life or widowhood and after her decease or Marriage the whole to be equally divided between my five beloved children to wit: Kezia ROSE, Mary HOLLOWAY, Sary ROSE, Elizabeth ROSE, Susanna ROSE. Signed by Emanuel with his "X" in presence of Test John HAMMON, Wm. DUMMON, H. GORDON C.C.

So, were John Hamon (spelled different ways in the records) and Mary (Hampton), Rose related? An Account of Emanuel Rose's Estate July Term 1799

Six doors from Emanuel's household is that of Stephen HOLLOWAY's, whose son John married Mary ROSE, who on occasion has had Ann or Ellen added as a middle name, daughter of Emanuel & Mary ROSE sometime before Emanuel's death because she is Mary HOLLOWAY in his Will. When Mary's 2<sup>nd</sup> husband John HALL, Sr. died ca 1815, John HOLLOWAY was Mary's surety.

### Mt. Airy Couple Obeserve Golden Wedding Tuesday

Another of Mount Airy's "Golden Wedding" couples came to light this week, with the observance of their 50th anniversary of marriage last Tuesday, January 17th. That was Mr. and Mrs. J. S. Rose, natives of Wilkes county, but for the past 25 or 30 years residents of Surry county.

Mr. Rose, a retired mail carrier, was born on August 20, 1867. Mrs. Rose, who was before her marriage, Miss Mary Bell Byrd, was born on May 10, 1872. They were married on January 17, 1889, and have five children living. The children are: J. C. Rose, of Mount Airy; C. M. Rose, of West End: Mrs. W. A. Potts, Mrs. G. A. Kemp and Mrs. H. L. Pruitt, all of Mount Airy. They also have 17 grandchildren and one great grandchild.

#### ELDER T. J. LAWSON

Was born January 10, 1822, and died January 20, 1904. His age was 82 years and 10 days. He was born out of lawful wedlock, and his mother being poor in earthly store, he was taken and raised by one Mr. Thomas Bryan. We suppose Mr. Bryan was very kind to him, for the writer has often heard him speak as if in loving remembrance of "uncle Tommy."

At the time the little Lawson boy was being

raised, education had not gained such a degree of prominence as at the present, and he only learned to read and write.

He joined the church at Franklin, on the 1st Saturday in May, 1858. He was ordained to the office of deacon in May, 1859; and ordained to the work of the ministry January, 1863. He served in the ministry, after his ordination, about forty-one years; and was a very able and gifted preacher. He but seldom traveled to any great distance from home, but preached mostly in his immediate section, where he lived. He could command a larger congregation than any other preacher in the Fisher's River Association.

He never accumulated any great amount of property; but his honest, humble manner of deportment, and his uncompromising faithfulness to his trust, gave to him the confidence of worthiness among the very highest order of men, and gave to him the utmost confidence of those who entertained a contrary opinion.

He manifested three distinct talents—preacher, teacher, and pastor. And the churches generally prospered where he attended.
