WILLIAM REVERE WELLBORN, M.D. Born December 17, 1882. Died May 24, 1943. Married December 29, 1908, to Miss Corrie Henderson of Mecklenburg County, Charlotte, North Carolina. Dr. Wellborn was a native of Ashe County, North Carolina, but his family shortly after his birth in Ashe, moved to Wilkesboro. His home at that time was in a grove of mighty Oak trees which still stand today near the highway leading to the Wilkes dam and is a short distance from the present location of the processing plant of Holly Farms. Through a portion of the old homeplace there is a street named Wellborn which can be identified easily at this time. Dr. Wellborn attended Davidson College and graduated from North Carolina Medical College, Davidson-Charlotte, May 15, 1905. He was licensed to practice medicine in North Carolina on June 16, 1908. He was an excellent student and after graduation took an internship and later took post-graduate work at the Post-Graduate Hospital, New York City.

Dr. Wellborn practices for a short time in Coleridge, Randolph County, and then came to Elkin in 1909 where he built up a successful practice as a General Practitioner. He was the son of Mr. J. M. Wellborn who was the owner and operator of a harness shop in North Wilkesboro for years. The original building with the name "J. M. Wellborn" is still visible in North Wilkesboro near the depot. His mother was Silas Rudd, her family being originally from Texas. Dr. Wellborn was a charter member of the Elkin Kiwanis Club, a member of the Masonic Fraternity, and on the staff of Hugh Chatham Memorial Hospital in Elkin. He was a member of the Surry County Medical Society, the North Carolina Medical Society, and the American Medical Association. Dr. Wellborn originally belonged to the Baptist Church, but became active in the Presbyterian Church and joined

this church and later became an elder. He was one of the members who was instrumental in the erection of the new Presbyterian Church on North Bridge Street in Elkin. Dr. Wellborn was a member of the Isaac-Walton Club and for years enjoyed hunting and fishing and raised bird dogs as a hobby. His prime interest was his patients and their health, and he was keenly interested in them as individuals, friends and neighbors, and not just in a professional manner. He was keenly interested in all phases of medicine and kept up-to-date in the advances in medicine.

After long years of arduous and difficult practice in the foothills of the Blue Ridge Mountains in Elkin and the surrounding area, first in the "horse and buggy days" and later in the "Model-T" Dr. Wellborn developed a heart condition from which he suffered for several years. Within this period of time he was unable to do heavy work but because of his love for medicine and for his fellowmen he built a small office attached to his home to continue to do office work. In fact, it was actually during the practice of medicine while seeing a patient that he suffered his final heart attack and died on May 24, 1943.

At his death, Dr. Wellborn was survivied by his wife, Corrie Henderson Wellborn; two daughters, Mrs. Catherine Wellborn Reece, of Greer, South Carolina, and Mrs. Edwin Duncan, Sr., of Sparta, North Carolina; one son, William Revere Wellborn, Jr., M.D. who was in internship and military service at that time. Since that time Mrs. Reece is deceased, Mrs. Edwin Duncan is living in Sparta, and Dr. Wellborn, Jr., is a specialist and a diplomat of the American Board of Obstetrics and Gynecology and is practicing in Morganton, North Carolina.

The esteem and love with which Dr. Wellborn was held by friends, patients, and the community is best expressed by one of his practicing colleagues, Dr. James W. Davis, of Statesville, North Carolina. A copy of this memoriam is included.
