PROCEEDINGS

FRIDAY, JULY 6TH, 1945

1st. Service was introduced by song and prayer by Eld. Watt Tuttle of Upper Mayo association, and Introductory sermon preached by Eld. J. R. Crews of this Association. No text used.

2nd. After intermission the Association met in the house and after song and prayer by Eld. J. S. Harris of New River Association, proceeded as follows.

3rd. Appointed Elders J. R. Beasley, W. C. Martin and M. H. Vaden, all of Upper Mayo association, to preach at the stand.

4th. Read letters from churches (except Pleasant Grove and Mulberry, not represented) and messengers seated, Chestnut Grove asked for the next association.

5th. Elected Elder F. P. Stone, Moderator, and G. J. Key, Clerk to serve another year.

6th. Called for petitionary letter. There was none.

7th. Called for Correspondents from sister associations and response was as follows, viz:

S. J. Jones and C. L. Slawter to serve with the Moderator and representatives of this (Zion Hill) church as committee on preaching.

11th. Agreed to meet in association tomorrow at 10 o'clock and for preaching at 10:30 Eastern War Time.

12. This minute read and received.

13th. Adjourned to meet tomorrow at time agreed upon.

SATURDAY MORNING, JULY 7TH

lst. The association was opened by song and prayer by Elder J. R. Worrell.

2nd. Messengers from Deep Creek, Pleasant Grove and Mulberry churches, were received and seated after having read letters from Pleasant Grove and Mulberry.

3rd. Called roll of Messengers.

4th. Called for correspondents and visitors from sister associations with response as follows, viz., Elder Ed Davis, Bro. F. T. Miller, Cor. from Senter; Elds. J. A. Fagg and W. J. Brown, visitors trom Upper Mayo; Elder C. D. Hall and Bro. W. C. Hall. Cor. from Roaring River, Brother and Sister C. F. Shields, visitors from Saint's Delight, Elder J. M. Edwards, Brethren Arnold Combs and C. T. Edwards, visitors from New River. All messengers and visitors seated.

5th. Called for report of committee on arrangements. They recommended releasing J. T. Riggan as Trustee to property of former Rock Springs church and appointment of T. M. Simpson to succeed J. M. Eldridge, S. J. Jones to succeed J. T. Riggan, and J. M. Hunter to succeed A. B. Key, Trustees to said property. The committee's recommendation was received and adopted by the association.

6th. Appointed Eld. J. R. Crews to write next circular letter.

7th. Read circular letter and ordered same attached to this minute.

8th. Called for report of correspondents appointed to visit sister associations. They reported and were discharged.

9th. Agreed to have 1200 minutes printed and distributed as usual.

10th. Agreed to give Moderator \$15.00 and Clerk \$20.00 for their service.

C.

13th. Called for report of finance committee. They reported \$193.20 received from churches.

14th. Agreed to give all surplus funds to visiting elders.

15th. Ordered rules of decorum and articles of faith, printed in this minute.

16th. Passed a resolution of thanks to Brethren, Sisters and Friends for caring for this association.

17th. This minute read and approved.

18th. Closed the work of the association by song and prayer by Elder G. S. Williams. F. P. STONE, Moderator;

ARTICLES OF FAITH

Article I. Of God and the Holy Trinity.

We believe in only the one true and living God, who rules all things after His own will; and that He, who created all things, is infinite in power, wisdom, knowledge and goodness, eternal, immortal, invisible and unchangeable; and that this God has revealed Himself in His word under the character of Father, and that these three are one; and that there are three that bear witness in earth --the water, the spirit and the blood, and that these three agree in one.

Article II. Of Holy Scriptures.

We believe that the Holy Scriptures of the Old and New Testament are the written word of God, and are a sufficient rule of faith and practice; that they are given by inspiration of God, and are profitable for reproof, for correction, and for instruction; in righteousness; and that they contain all things necessary to be known for the salvation of men and women.

Article III. Of the Atonement.

We believe that Christ died and made a complete atonement for all who ever does now, or ever will believe on His name, and that all who are finally saved were given to Christ in covenant of the Father before the world was, that they should show forth his praise.

Article IV. Of Foreknowledge, Election and Predestination.

We believe hat (all) of whom God did foreknow He did also predestinate to conform to the image of His Son; that God elected according to His foreknowledge, through sanctification of the Spirit unto obedience and sprinkling of the blood of Jesus Christ, all who are finally saved, to an inheritance incorruptable and undefiled and that fadeth not away, reserved in Heaven for all true Saints; and that none come to Christ only those whom He loved with an everasting love and in due time calls to everlasting Glory.

Article V. We believe in the doctrine of original sin.

Article VI. We believe in man's impotency to recover himself from the fallen state he is in by his own free will and ability.

Article VII. We believe that sinners are justified in the sight of God only by the imputed righteousness of Christ.

Article VIII. We believe that God's elect will be called, converted regenerated and sanctified by the Holy Spirit.

Article IX. We believe the saints shall persevere in grace and never finally fall away.

Article X. We believe that baptism and the Lord's supper are ordinances of Jesus Christ and that true believers are the only proper subject of the ordinances, and that the true mode of baptism is 'by immersion.

Article XI. We believe in the resurrection of the dead and a general judgment.

Article XII. We believe the punishment of the wicked will be eternal and the joys of the righteous everlasting.

Article XIII. We believe that no minister has the right to administer the ordinances only such as are regularly called and have come under the imposition of the hands of the Presbytery.

RULES OF DECORUM

I. The Association shall be opened and closed with prayer.

II. The moderator and clerk shall be chosen by the sufferage of the members present.

III. Only one person shall speak at a time, who shall arise from his seat and address the moderator.

IV. The person thus speaking shall not be interrupted in his speech by any, except the moderator, until he is done speaking.

V. He shall strictly adhere to the subject, and in no wise reflect on the person who spoke before, so as to make remarks on his slips, iailing or imperfections, but shall fairly state the case and matter, as near as he can, so as to convey his idea.

VI. No person shall abruptly break off, or absent himself from the Association without leave from it.

VII. No person shall rise and speak more than three times on one subject, without liberty obtained from the Association.

VIII. No members of the Association shall have the liberty of laughing during the sitting of the same nor of whispering in time of a public speech.

IX. No members of the Association shall address another in any appellation other than that of Brother.

X. The moderator shall not interrupt any member in his speech nor prohibit him from speaking 'till he gives light on the subject except he break the rules of this decorum.

XI. The names of the several members of the Association shall be enrolled by the clerk and called over as the Association thinks proper.

XII. The moderator shall be entitled to the same privilege of speech as other members, provided the chair be filled.

XIII. Any member who shall willfully and knowingly break any of these rules shall be reproved by the Association as it may think proper.

CIRCULAR LETTER

Dear Brethren and Sisters of the Fishers River Association and everywhere. Being appointed by the Association to write this letter I will try to write on the teachings of Christ.
