RE: Minutes of November 6, 1975 meeting

The meeting was called to order by Dr. Simmons at 7:30 p.m.. The new members appointed to the Bicentennial Commission were then introduced: Mr. Bud Cameron, Mr. Carroll Gardner, Ms. Joyce Feezor, Mr. Jack Palmer, Mr. Doug Cook, Mr. Gene Everett, Mr. Claude Elridge, and Mr. Bill Hiatt. Those who have officially accepted the nomination but could not attend because of prior commitments were: Mrs. Vivian Lowe, Mr. L.H. Jones, Mr. Charles Fletcher, and Mr. Vincent Lilla. Two nominees had not sent their written notice of acceptance or rejection at the time of the meeting: Mr. Bill Hearn, and Mrs. Beulah Perkins.

The reading of the minutes of the last meeting were then read and approved.

A report on the festival was then made jointly by Dr. Simmons and Mr. Spanski. Mr. Spanski gave a general over-view of the scope of the Festival plans for the week of July 3 through July 10, 1976. He described the Pogers Co. Plans for the Festival in brief.

Dr. Simmons then reported that a professional consultant from the Rogers Co., Mr. Phillip Frable, had visited us in the week of October 13, to October 17 and had made the following recommendations: that the festival is in serious trouble because: one, we do not have the important executive positions in the festival organization chart filled, and two, the general chairman of the Festival needed to be replaced. Both of these problems are to be solved soon, in fact, no later than December 1st of this year.

Dr. Simmons reported that one of these problems had been resolved by the appointment of Ms. Cama Merritt as the new general chairman of the Festival. She was then introduced to the Commission and stated that she would immediately work on the other problem of selecting the major executive positions in the Festival organization.

Dr. Simmons also noted that the Surry County Bicentennial Commission had made notable progress in the implementing the first Bicentennial historic sign program in the state; of receiving a \$10,000 grant for the restoration of Rockford from the General Assembly; the publication of a number of historical booklets written by Ruth Minick as well as her weekly contributions on the history of Surry County in the local newspapers; the establishment of a county archives in conjunction with Surry Community College and other achievements in the Heritage area of the Bicentennial.

Dr. Simmons further reported that Mr. Frable had stroghly recommended that because of the general apathy connected with the national Bicentennial we as an organization should as much as possible dissociate ourselves from the national organization. We should instead develop our individual image as a local bicentennial organization.

Mr. Spanski then made a report on the "Come As Your Favorite Historical Charac contest, which was held in conjunction with the Autumn leaves festival. In total there were 16 persons in the adult contest (Terry Pruett dressed as Uncle Sam won first proze) and 14 in the children's contest. Mr. Spanski remarked that the quality of the costumes was high and demonstrated originality. The audience reaction was quite good to the event.

Mr. Bill Hiatt of the Finance Committee then made a brief report on the Finance campaign which has collected to date \$9660.00 from businesses and individuals. Another approximate \$4,000 in pledges are forthcoming in 1976. This amount is barely sufficient for seed money to finance the Festival and some other projects but not for a ;full program as orginally planned by the Commission. Further efforts are being made to raise more money. Mr. Comer suggested that the muncipal governments in Surry be contacted for financial assistance. It was also suggested that a campaign be started in the school systems.

A report by Mr. Spanski was made on the U.S. Armed Force Bicentennial Caravan which is expected to be in Dobson on Friday, November 14, 1975. Mr. Robertson reported that almost all arrangements with the county and city school systems had been made and that about 1,000 school children would see the caravan. Mr. Spanski reported that the special chairman for the event would be Lt. Col. David Hatchae (ret) former P.O.W.. Mr. Spanski urged that members of the Bicentennial C Commission should attend the opening ceremony at the County Courthouse at 12 noon.

Mr. Spanski made a brief report on the Colonial Tasting Spree project. Because of the planning difficulties, the project was delayed from early December to Eastertime, 1976.

Mr. Steve Taylor made a report on the Historic Sign program and said the signs are now ready for the Dobson, Elkin, Shoals and other areas; the Boy Scouts will be responsible for erecting such signs. A sign for the Franklin House is already erected.

NEW BUSINESS: Dr Simmons asked the nominating committee headed by Glenn Robertson to nominate a new vice-chairman and an new secretary for the Surry County Bicentennial Commission. This report should be made for the next scheduled meeting, Thursday, Dec. 4, 1975 at 7:30 p.m. at Surry Community College.

Motion for adjournment was made and seconded. The meeting was duly adjourned.
