PROCEEDINGS

FRIDAY MORNING SESSION, AUGUST 2, 1946

The Yadkin Valley Missionary Baptist Association met with the Mt. Mariah Missionary Baptist Church on Friday before the fourth Sunday in August, 1946, at 9:30 A. M. to hold its sixtyfifth annual session.

Service was opened by Bro. Larence Wilborn, who lined hymn No. 392. "Must Jesus Bear the Cross Alone." After a few remarks, he introduced Rev. Dennis Palmer to preach the introductory sermon. Rev. Palmer took a text from Hebrews 5:8. "Though He Was a Son, Yet, He Learned Obedience." His subject was, "The Education of the Son of God." He preached a very encouraging sermon from this text, closing by singing, "We Will Understand It Better By and By." Prayer was offered by Bro. Cephus Wilborn. Ten minutes intermission was given.

On reassembling, the house was called to order by singing, "Down at the Cross." The Rev. J. A. Parson, Moderator from last session, made a few remarks and read a scripture lesson from St. John 3, 1st through the 6th verse. He taught an enlightening lesson from this scripture. Prayer was offered by Rev. L. J. Carlton. After singing "I Heard The Voice," the welcome address was given by Bro. Kellem, who made all feel quite at home, stressing the idea of having the best session in the history of the Association. The response was given by the Rev. L. J. Carlton. The house was declared ready for business.

Motion was carried to use the program as a guide. It was also decided to recognize the old constitution and by-laws. The letters were passed in to the secretary and delegates enrolled. After enrolling the delegates, the house went into permanent organization.

A motion carried to re-elect all officers who were present. They were as follows:

A motion was carried to dismiss for dinner.

FRIDAY AFTERNOON SESSION

At 2:00 o'clock Friday afternoon, service was opened by singing "A Charge To Keep I Have." Prayer was offered by Bro. Barber. The Scripture was read by The Moderator, who, after a brief explanation of the Scripture, declared the house ready for business.

The minutes of the morning session were read and received. The roll of the delegates was called. All who were called were present. As the congregation sang "Come We That Love The Lord," an invitation was extended to newly constituted churches and visiting brothers.

Resuming business from the before-noon session, Report No. 1, which reported the correction of the letter from Popular Springs Church, was read and received. Report No. 2—that committees be appointed on various topics. The moderator then appointed committees on various topics. A motion was carried that the business part of the association adjourn to meet Saturday morning at 9:00 o'clock. Dismissal without benediction followed.

FRIDAY NIGHT SERVICE

At 7:30 the devotion service was conducted by the delegates from Mt. Moriah, who rendered a short prayer service which was enjoyed by all. The program was followed by the welcome address on the part of the church by the pastor, the Rev. N. A. White; a welcome in the community by the deacon, Mr. Sawyers; a solo by Miss Helen Kellam. The response was given by the Rev. L. J. Carlton. The Welcome addresses made everyone feel quite at home. The service was then turned into the hands of the ministers, Rev. J. C. Rowe and Bro. Howell. "A Charge To Keep I Have" was sung. Prayer was offered by the Rev. J. A. Parson. After singing "Go Preach My Gospel," the Rev. Rowe took a text from St. John 1:23, words of text: "I am the voice of one crying in the wilderness; subject, "A Man Sent From God." He preached a soulstirring sermon from this text, stressing the point that one sent from God could not fail in life. As the congregation sang "Precious Lord Take My Hand," the board lifted a collection amounting to \$22.00. Offertory prayer was offered by Bro. Howell. Announcements were given by the Moderator. The benediction was given by the Rev. Rowe.

SATURDAY MORNING SESSION

Promptly at 9:00 o'clock Saturday morning, service was opened by singing "Take Your Burden To The Lord and Leave It There." The Moderator made some encouraging remarks and read a Scripture lesson from St. John, 10th chapter, 1-9 verses. He taught a beautiful lesson from same, bringing out the point that we may not get what we want in this life, but we can have religion and eternal life after death. Prayer was offered by Bro. O. G. Mitchell. After singing "Bread of Heaven," the Moderator declared the house ready for business. The roll of the delegates was called. The minutes of the Friday evening session were read. The reports of the various topics were called for and placed on the table by the different committees and were read as follows:

(1) Home Mission; (2) Presbytery; (3) Publication of Minutes; (4) Examination of Treasury.

Before being received, these reports were discussed in their fullness. A motion was then taken for ten minutes recess before the 11:00 o'clock preaching services. Dismissed without benediction.

ELEVEN O'CLOCK PREACHING SERVICE

The missionary, The Rev. I. P. Rowe, and Rev. C. B. Baily were in charge of the 11:00 o'clock service. Service was opened at 11:00 o'clock by the Rev. Bailey, who lined hymn No. 266. Prayer was offered by the Rev. E. L. Long. The scripture lesson was read by the Rev. Bailey, found in St. Mark, 10th chapter, be-

ginning at the 33rd verse, extending through the 43rd verse. After singing "Working On The Building," the Rev. Bailey introduced the Rev. I. P. Rowe to preach the missionary sermon. The Rev. Rowe took his text from St. Mark 1:27, "For He taught them as one having authority, not as a scribe." He preached a wonderful sermon from this text, stressing the idea of being properly trained and having authority from God to be a successful missionary. He closed his sermon by singing "When The Gates Swing Open, Let Me In." The board lifted an offering amounting to \$13.10, and the offertory prayer was given by the Rev. Bailey.

The service was then turned over to the Moderator who, after a few remarks, declared the house ready for business. An invitation was then extended to newly constituted churches and visiting ministers and brothers. The Rev. Fowler and the Rev. Rutherford came forward bringing greetings from the Mt. Catawba Association. They made some very interesting remarks praising the moderator and the delegates for the good service of the association. The Rev. William Turner also made some encouraging remarks. The Rev. Baxter, claiming not to be a visitor, made a splendid talk, stressing the idea of Home Mission. He mentioned the incident of the four murders that took place in the community in which he is now pastoring in the state of Georgia, and said that we must learn to adjust ourselves to conditions and work wherever our spirit tells us. The address was followed by a rising vote of thanks for the address given to the association. A motion was carried to adjourn for dinner until 2:00 o'clock P. M. Benediction by the Rev. L. J. Carlton.

SATURDAY AFTERNOON SESSION

The service was opened at 2:00 o'clock by the singing of the hymn, "Come To Jesus." The Scripture lesson was read by the Moderator, found in Romans 10:1. After a few remarks and Bro. Lackey singing "Precious Lord, Take My Hand," the house was declared ready for business.

The reading of the minutes of the forenoon session, and the roll of the delegates was called. The remainder of the reports was read as follows: (5) Foreign Missions, (6) Constitution and By-Laws, (7) Finance, (8) Resolutions.

Section number two of the resolutions was voted down and turned back into the hands of the Presbytery and the Board to work out some means by which a pastor in the valley may become a member of the association. The joint committee of the Presbytery and Board made their report. While they were absent, a devotional service was carried on by the delegates. The printing press was turned into the hands of the Board in order to decide what was to be done with it. The ministers and deacons meeting was reported to be held on Friday before the fifth Sunday in Septem-

ber. The Board reported that the report on distribution, and all other business reports would be read the following night. The report on the enrollment of ministers was read and received. The report on Time and Place was read and received. All other reports were received under one heading with the proper corrections. A motion was carried that the business part of the Association be closed until Friday before the fourth Sunday in August at 9:00 o'clock, 1947, to meet with the Mt. Valley Missionary Baptist Church, near Ronda, North Carolina. The Board reported that the Rev. D. W. Rutherford and the Rev. R. W. Barber would conduct services Saturday night. The Moderator asked the delegates to stand and help him sing two verses of "A Charge To Keep," and he asked for the hands of all delegates. The song was beautifully sung by the congregation. The benediction was given by the Rev. L. J. Carlton.

SATURDAY NIGHT SERVICE

The devotion service was conducted by a group of delegates with the Rev. Palmer in charge of the song service. After a group of spirituals were sung, the paster, Rev. H. A. White, gave words of thanks to the friends of the community who helped to entertain the delegates. The service was then turned into the hands of the ministers.

After singing "I Don't Know What I'd Do Without The Lord," prayer was offered by Bro. W. M. Dowell. The Rev. Barber introduced the Rev. Rutherford who took his text from St. John 12:24-32. Text, "And If I Be Lifted Up From Earth, I Will Draw Men Into Me, Except A Corn Of Wheat Fall Into The Ground And Die, If Abideth Alone." Subject, "The Loneliness of Jesus." He preached a heart-warming sermon from this text, stresssing the point that too many people are looking for the better things in life and in heaven, but are not willing to pay the price. A solo was sung by Brother Lackey while the offering was taken by the board. The collection amounted to \$27.55. A second collection was taken for Brother Eldridge Dodd, a sick man in the community, amounting to \$11.35. Offertory prayer was given by the Rev. Barber. The reports of the board on the registration of the ministers and delegates, and the report on distributions were read. Announcements were given by the moderator and others. "A Charge To Keep I Have" was sung. The benediction was given by the Rev. Rutherford.

SUNDAY MORNING MASS MEETING

At nine o'clock sharp, the service was opened by the Rev. E. L. Long, by singing "Down At the Cross." The scripture lesson was taken from Sunday School Lesson, found in Exodus 20:14; Proverbs 4:14-23 and Matthew 5:8. After reading the scripture the Rev. Long commented on the lesson. Prayer was offered by

Brother Talmadge Harris. After several selections were sung, the house went into a round-table discussion. The topic was "The Problems Facing The Church In A War-Torn World."

This topic was discussed in its fullness by the delegates and ministers. All were enlightened and felt that they could better face the problems of life after having heard the discussion. The subject was summarized by the Rev. J. E. Baxter, who did a beautiful job comparing the human being with the lower animals; how they cared for and protected their young ones and the careless way of people solving problems of their young and protecting them. The board then took an offering for Brother Everett Martin of Jonesville, N. C., who wished to purchase a leg amounting to \$26.02. Offertory prayer was given by Brother C. C. Harris. Ten minutes intermission was given before the 11 o'clock preaching service. Dismissed without benediction.

SUNDAY MORNING ELEVEN A.M. PREACHING SERVICE

Service was opened by the Jonesville choir, which sang a group of spirituals. Service was then turned into the hands of the moderator, the Revs. J. A. Parson and L. J. Carlton, to preach the annual sermon. Prayer was offered by the Rev. E. L. Long. After singing the hymn "Amazing Grace," the Rev. Parson took a text from John 1:29; "And the next day John saw Jesus coming unto him and said, 'Behold the Lamb of God that taketh away the sins of the world." He preached the most powerful sermon in his preaching career from this text, emphasizing the point that no one could be found on earth worthy to give a remedy whereby man might be saved after sin entered the world. He proved also that God sent his only begotten son that all men might be saved. The sermon was similar to "The Sermon On The Mountain." Everyone seemed to feel the spirit. The choir then sang "A Happy Home On High." The choir sang another group of spirituals while the Board took an offering amounting to \$51.36. Offertory prayer was given by the Rev. E. L. Long.

Sister Mildred Kellam from West Virginia turned in an offering to the board amounting to \$39.00 which she had collected from members of the church in Virginia. The board turned the \$39.00 over to the church, as it was a church affair. The Rev. L. J. Carlton presented words of thanks to the members and friends of the church for the kindness shown to the delegates and visitors while in the community. The Rev. White, brother to the pastor of Mt. Mariah Church, gave some very encouraging remarks as to how the church and various auxiliaries had planned for the reception of the association. After singing "Blest Be The Tie That Binds Our Hearts," the benediction was given by the Rev. E. L. Long.

MISSIONARY CIRCLES REPORTS I.—PATTERSON GROVE OBITUARY

The Rev. W. M. Patterson was born in the year 1897. He became minister at an early age. In his later years he became a successful pastor in the Yadkin Valley Association and did a splendid job with his work. He also served as president of the Sunday School Convention and encouraged the Sunday School to keep alive wherever he pastored. On June 20th, 1946, he died at the age of 49. At the time of his death he was serving as president of the Sunday School Convention and was pastoring three churches in the valley.

Sister Emma Cain Russell was born July 29, 1862 and joined the Pleasant Hill Baptist Church and was a faithful member almost ever since it was established. Sister Bessie McMillan Harris was born September 4, 1880 in Ashe County. She was united in matrimony with the late Lee Andrews Harris. To this union were born 15 children. CONSTITUTION

ARTICLE 1.—This Association shall be known as the Yadkin Valley Missionary Baptist Association.

ARTICLE 2.—This Association shall be composed of regular Missionary Baptist Churches in good standing and in full practice of the doctrines. The object of this Association shall be the promotion of Christ's kingdom upon earth.

ARTICLE 3.—The delegates selected should bear from each church, respectively, a letter certifying their appointment and communicating information relative to the state of the church and the interests thereof.

ARTICLE 4.—This Association just formed shall meet annually on Thursday at 2 o'clock P. M., before the fourth Sunday in August. Before organization, all letters shall be read and approved. The Association shall elect by ballot a Moderator, Vice-Moderator, Clerk, Treasurer—for general relief and foreign and home missions and orphans home, finances—who will continue in office one year or until others are elected.

ARTICLE 5.—It shall be the duty of the Moderator to preside at business meetings of the Association, to keep order during each session, to decide questions of order subject to an appeal to the house by any member and to perform all other duties pertaining to his office.

ARTICLE 6.—It shall be the duty of the Clerk to keep a faithful and correct record of all the proceedings of each session of the Association, to transcribe them in a book kept for the purpose and to perform all other duties assigned him by the Association.

ARTICLE 7.—It shall be the duty of the Treasurer to keep a correct record of all funds coming into his hands and to report the same at the order of the Association.

ARTICLE 8.—There shall be a committee of arrangements consisting of five members beside the Moderator and Clerk.

ARTICLE 9.—All letters of grievance, together with queries and letters from corresponding associations requiring any attention shall be submitted to the committee of arrangements and be reported back to the Association.

ARTICLE 10.—This body shall have no coercive power to exercise leadership over God's heritage, but shall be considered as an Advisory Council upon matters respecting internal regulations of the churches.

ARTICLE 11.—When an offense may have been committed by one church against another, or where serious difficulties may have arisen in an individual church, as the case may be, it shall take the matter into consideration and advise upon it.

ARTICLE 12.—The Association shall not maintain permanent fellowship towards any of her churches that neglect to institute and preserve gospel order among their members, or any of her churches and ministers who treat her constitution with contempt, but shall sustain with all her influences such as promote gospel principals and order.

ARTICLE 13.—It shall be the provinces of this Association to invite corresponding brethren to seats in the Association, but such will not be entitled to vote.

ARTICLE 14.—The Association shall, in all cases except matters pertaining to the Constitution, be governed by a majority of the members present, and shall not adjourn until they have gone through all of the business of the Association, except on extraordinary occasions.

ARTICLE 15.—Each church having ordained licensed ministers shall report the same to the Association in order that they may appear as such on the face of the Minutes.

ARTICLE 16.—The Association shall furnish the churches with the Minutes of its proceedings, and it shall be the duty of the churches to enable her to do so.

ARTICLE 17.—The Association has a fund created and sustained by voluntary contribution from the churches which shall be held by the Treasurer, subject to the disposition of a majority of the Association present at any annual meeting.

ARTICLE 18.—The Association shall have an annual session at such time and place as the body may from time to time designate.

Article 19.—By an appointment the Association may have an introductory, a missionary and a denominational sermon preached at each annual session.

ARTICLE 20.—The Constitution may be altered or amended at any time, two-thirds of the members concurring.

RULES

- 1.—This Association shall be opened with singing which shall be followed with a prayer by the Moderator or anyone appointed by him.
- 2.—The minutes of the preceeding session shall be read, corrected and approved.
- 3.—No brother shall be interrupted when speaking unless his remarks are foreign to the question under discussion. Any brother may arise to a point of order, or the Moderator may call him to the proposition under debate.
- 4.—When a member is called to order by the Moderator, he shall take his seat until it is determined by the Moderator if he is in order or not. Said member may appeal from the decision of the Moderator. The decision of the Association shall be final.
- 5.—No man shall speak more than twice upon the same subject not longer than five minutes, unless he obtains permission of the Association.
- 6.—No man shall be allowed to leave the house without per mission of the Moderator.
