

RULES FOR THE OPERATION OF THE MOUNT AIRY COUNTRY CLUB

CLUB HOUSE AND LOUNGE

It is the purpose of the Board of Directors to have a Club House and Lounge to facilitate the members of the Club. That is, to give service and supply all needs for the social demands of the members. With this in mind, rules must be explained that will benefit the majority of the members. The House Committee is responsible for the Club and reports to the Board of Directors all infractions of the below listed rules. Any member not abiding by the rules is subject to fines, suspensions, or paying for the damages.

LOUNGE: OPEN 4:00 p.m. Tuesday Through Sunday

1. Use of the Club for members and out of town guest only.
2. The wearing of golf shoes is prohibited.
3. Use of or the entrance of any person under 21 years of age is prohibited.
4. Members are responsible for their guest and, in all cases, all parties shall conduct themselves in a manner of good behavior.
5. No card playing will be permitted.
6. No one is permitted behind the bar or in the kitchen except authorized personnel.
7. Supplies and furnishings are not to be moved from the Lounge.
8. Any decorating of the Lounge must be cleared through the House Committee.
9. Lunches may be served in the Lounge at the members request.

DINNER:

1. Club members and guest only.
2. Reservations must be made for dinner by 7:00 p.m.
3. All dinners will be served in the dining room.
4. Private parties must be approved by the House Committee. (Charges listed below.)
5. Any food not purchased from the house caterer must be approved by the house caterer before being brought to the Club.
6. Members are responsible for their guest and, in all cases, all parties shall conduct themselves in a manner of good behavior.
7. No card playing will be permitted other than scheduled events for this purpose.
8. The attire for the dining room will be in keeping of the scheduled events.
9. Any decorating of the dining room will have to be approved by the House Committee.
10. Supplies and furnishings are not to be moved from the dining room.

LUNCHEES:

1. Lunches will be served on Wednesdays, Thursdays, Fridays, Saturdays, and Sundays from 11:00 'til 2:00. No reservations needed.

2. Lunch may be served in the Lounge or Dining Room.
3. Lunch will be served to the members using the pool on request. Lunch must be served on the patio or porch.
4. Luncheon parties of twenty (20) or more must be arranged with the house caterer.
5. Card tables will be set up on request by the house caterer for those desiring to play bridge after lunch.

MEN'S LOCKER ROOM:

1. The locker room is to be used by male members and their guest for locker storage of personal belongings.
2. Tables are available for the male members desiring to play cards.
3. Lunch will be served in the Locker Room at the request of the member.
4. Shoes will be shined by the club caretaker when placed in the racks provided. Members are responsible for paying for the service.
5. Any member not conducting himself in a manner of good behavior, or destroying Club property is subject to suspension by the Board of Directors.
6. Lockers are provided for use of the guest.
7. Towels will be furnished by the golf shop attendant for showers.

LADIES LOCKER ROOM:

1. Ladies locker room is under the supervision of the Golf Shop.

PRIVATE PARTIES AND CLUB RENTALS:

1. To rent the Club, application must be made and the lease signed for all responsibility.
2. Any decorating of the Club for private parties must be approved by the House Committee.
3. The Ballroom is the confined area for private parties.
4. The Club will not be available for private parties when any Club planned function is scheduled.
