Johnny Kidd's Work Is Never Done -He Performs the Domestic Duties

DOBSON-It's a man's world

DOBSON—It's a man's world
—no women needed—around the
Kidd brothers' home and farm.
For while Roy, the elder, is
in the fields tending crops,
Johnny is home cooking, canning, ironing and cleaning.
And on weekends, the Kidd
home is next thing to open
house at the community park of
yesteryear. Crowds flood to the
12-room white frame house several miles east of here on Turkey Ford Road. And they mill
around the large, well-kept yard
with its many, many flowers
and well-kept encircling hedge.
Furnishing music are the Kidd

Furnishing music are the Kidd brothers, with assistance from all others who wish to join them -with instruments or with

Johnny is the brother who plays. He not only plays the piano, organ, accordion and violin, but he also plays two pianos at the same 'time or a piano and the accordion simultaneously. He ''dreamed'' one night how to play the accordion, ordered one, unpacked it and began playing.

Roy leads the singing—and

Roy leads the singing—and there have been over 100 persons on these Sunday occasions

to lend their voices.

The Kidds are so hospitable

they don't have to extend in-vitations—people simply come invited or uninvited. Relatives of the brothers, who

come from a family of seven boys and four girls, drop in for Sunday dinner just as though the Kidd household had a woman in the kitchen. And they never complain about the food because Johnny is considered as good a cook as any woman—

good a cook as any woman—and better than most.

"I don't go in for fancy foods, he explains, "but just try to find someone who can beat me on vegetables, meats, biscuits and

cakes!"

The food is so good that Tom Kidd, another brother who is a widower and lives nearby, boards at the family home.

Johnny not only cooks, but cans jars and jars and jars of fruits and vegetables off fruit trees around the place and from the garden which he tends.

Asked how he got started doing the housework, Johnny ex-

Asked how he got started doing the housework, Johnny explained that his mother needed some help and the work seemed to fall to him. Although he had four sisters, they would "up and get married by the time they got old enough to be of much assistance."

Then for three years before

Then for three years before her death 10 years ago, their mother was a complete invalid and they took care of her.

Roy, although he had passed the 70 mark, is still quite active and tends several acres of to-bacco on their 60-acre farm. The family homeplace originally had more than 300 acres before being divided among the chil-

dren.

The Kidd family came down from Pennsylvania about 1811 and settled "just across the river" from the present house. The first portion of the house was built 80 years ago, and two additions since then have increased its size to 12 rooms and three big porches. Several pieces of Johnny's needlework decorate the house. The needlework is indirect contrast to the robust, masculine wielder of the needle. masculine wielder of the needle.

Johnny maintains the house so immaculately that visiting female housekeepers get inferior-ity complexes. He also does the family wash.

His comments would sound familiar to most housewives. Such as "I washed yesterday, but I ain't ironed any yet this week."

Benjamin Kidd A Soldier of the Revolution from Virginia 1777-1779

On November 13, 1852, Jesse Kidd as a resident "near Mt. Airy" appeared before A. Dunnagan, Justice of the Peace in Surry County, North Carolina as the "legitimate heir" and "identical child" of Benjamin Kidd "who was a soldier in the war of the Revolution" as stated on the official form. Jesse hired Samuel M. Knight of Washington City and gave him power of attorney to "prosecute the claim of Benjamin Kidd for any amount of Revolutionary Pension, or increase of Pension that may be due." No documented resolution of the claim resides in the National Archives other than an envelope that is stamped "Rejected" and appears in the same collection of documents from which the following transcript was made.

In June 1838, Jesse took Benjamin to see Elyah Thompson to apply for his pension. Here is my verbatim transcription of his statement (completed September 6, 1999) from a copy in microfilm files at the National Archives, M-804, Roll #1480, Pension R5906:

QUOTE

Declaration in order to obtain the benefit of the act of Congress passed June 7th 1832

State of North Carolina County of Surry

On this the 9th day of June 1838 personally appeared before me Elyah Thompson, a justice of the County Court of Surry County in the State of North Carolina, Benjamin Kid aged 86 years (he being unable to travel to court) so being first duly sworn according to law, doth on his Oath make the following Declaration in order to obtain the bennifit of the provision of the act of Congress passed June 7th 1832, that he entered the service of the United States under the following named officers and served as herein after stated (to wit) I was bornd in Buckingham County Virginia in the year 1752 I have no record of my age, and only know my age from what I have been told-when called into the service I lived in Buckingham County Va- Continued to live there for several years after the Revolutionary war-then moved into Surry County NC in which County I now live.

I was Inlisted in the service of the United States in the year 1777 for three years. I think in the month of March by Capt John Nickolds or Nickles. I was promised as a bounty forty dollars in money-too suits of Cloathing per year & one Hundred acres of land, twenty dollars is all that I ever received of my bounty. I was taken sick and was not not able to march with my Capt when he marched his company off. At my recovery I was put in the company commanded by Capt Thomas Betoo and by him marched to the Long Islands of Holston. at this place I was commanded Col Christy, we was here stationed about three months. I was then put in a company commanded by Capt John Looney and by him marched to Carter's Valley. there we built a fort and guarded it for ten or twelve months. I was then put in a company commanded by Capt George Freeland and by him marched to Blackamores fort near Clinch river near a place called the Elkgarden and was there stationed about three months. I was then then marched by George Brooks (I do not recollect what grade

of office he held) to Wkilliys (whittiys) fort in Kentuckey and here Stationed one month & some few days. at this place I was commanded by Capt Whitly. I was here put in a company commanded by Capt John Chisum & by him marched to Logans Station and here stationed one month. this place I was marched by the afforesaid Capt Chisum to Harrodsburgh. This was commanded by Capt James Harrod. I was here stationed seven months, tho often out with skouting partys after the Indians. we took some few Indians prisoners, but was in no General Ingagements. sometimes at this place my bread rations was four ears of corn per day & 1/4 pounds of meat when the hunters could kill it. I was then marched to the falls of the Ohio by a Capt whose name I have forgot. at this place I was put in Capt John Rogers Company & by him marched to the Opost on Waubash I do not recollect which it was called. at this place we was under Cleark, I do not recollect wahat grad office he held, here we took Hamilton & his men (102 or 103) at this place we stayed but a short time. I was now informed that we was to gard the afforesaid prisoners to Harrodsburg Kentuckey at which place we arrived in January at which place we remained with the afforesaid prisoners (Hamilton & his men) until the first of may following. I was now informed that we was to gard the afforesaid prisoners (Hamilton & his men) to Williamsburgh Va to which place we now started. I still remained in Company commanded by the afforesaid Capt John Rogers. The Army was now commanded by Col Richard Callaway. as we marched and come near linchburgh Va I was Informed all that had relations near could go and see them accordingly I received a written Discharg I do not recollect whether my Capt Rogers spigned it or Col Callaway but I lost it long ago. The officers was to go and draw our mony and come back and pay us-and was all to go to Kentucky together as it was a rich Desireable Country-but I have never seen Officers nor money from that day to this. I do not recollect the names of any other Officers but those already mentioned-I served three years as a private for which I claim a pension-I know of no person by whom I can prove my services, nor have I any Documentary Evidence thereof-

I am known to a Clergyman residing in my neighborhood William Howard Esq who can testify to my Character for Varasity. I hereby relinquish every claim whatsoever to a pension or anuity Except the present-Did as that my name is not on the pension roll of the agency of any state, Territory or District,

Mr. Thompson also took the testimonial of the two men mentioned by Benjamin as follows:

QUOTE

We Silas Jones- a clergyman residing in the Cty of Surry N.C. and William Howard a resident of said County do hereby certify that we are well acquainted with Benjamin Kidd who has sworn to and subscribed the foregoing Declaration that we believe him to to be 86 years of age, that we believe him to be a man of verasity-that we have heard it current reported that said applicant was a soldier of the Revolution, that that

report is believed in his neighborhood and that we concur in that belief. Sworn to and subscribed the day & year afforesaid

Silas Jones a preacher of the Baptist Denomination Wm H. Howard

And I Elyah Thompson declar my opinion after investigating of the matter of the application of Benjamin Kidd for a pension had before me, a Justice of the County Court of Surry in the state of NC that the foregoing are the proceedings on the same. I further declare that after a full investigation of the matter and putting the interogatory requested by the war department that the said applicant was a soldier of the Revolution and served as he states I further certify that the said applicant is unable on account of grate age & infirmity to travel to court, - I also certify that whose name appears to the above certificates is a clergyman residing in this county (Surry NC) and that William H Howard whose name also appears to the said certificate is a respectable resident of said Cty and that the statement sworn to and subscribed by them is intitled to ercerdit (a credit?),

Will of Benjamin Kidd

In the name of God Amen

I Benjamin Kidd being of sound mind and memory knowing the certainty of Death and the uncertainty of life do make and consecrate this to be my last will and testament revoking all others heretofore by me made.

First I will that after I am dead my body be decently buried in a Christian like manner.

2nd all my just debts to be paid 3rd I will and bequeath to my beloved daughter Sarah Kidd to have all the property that I now possess together with my income which I conceive will hardly make her coequal with the rest of my children that has left me and to make her compensation now for her services rendered to me which in my Illness.

Lastly by these presents I appoint Sarah Kidd as her own Executor and we let or hands and seals in the name of the Lord One thousand Eight Hundred and forty Seven.

We found a little on James Kidd in Surry County but do not know if it is your James Kidd. It appears a James Kidd was in Surry to witness a deed as early as 1805 but he was not found on any census records until 1820 in Surry County. We do not know if this is the son of Benjamin Kidd or not as he was the only other Kidd in Surry in 1820.

Below is what we found on James Kidd:

James Kidd may have left Surry County sometime after 1822. A James M. Kidd was found in Wilkes Co., NC in the 1830 census records.

James Kidd, age 60, farmer, b. NC, is listed in the Poor House (old age) in the 1850 Surry County Census.

Jesse James Kidd, b. ca. 1797, son of Benjamin, was probably born in VA but came to Surry County early in life. He married Susannah Greenwood 3 Jan 1816. He had three children: Rebecca, Benjamin F. and Martha E. (info in the Allen Kidd family history in "The Heritage of Surry County, NC" Vol. II)

William Kidd (1675-1727), son of Thomas and Jane Kidd, married Margaret and had ten children: Margaret, Robert, Aggatha, Moses, Dirrell, Aaron, twins William and James, Samuel and Catharine. (info in the Allen Kidd family history in "The Heritage of Surry County, NC" Vol. II)

James Kidd witnessed a deed of James Howard dated 9 Nov 1805 in Surry Co., NC.

James Kidd was listed on the 1819 Surry County Tax List (1 white poll), 100 acres adjoining Charles Chrisman, and on the 1822 Surry County Tax List (1 white poll).

1820 Surry County, NC Census:

James Kid - 2 WM 0-10, 1 WM 26-45, 2 F 0-10, 1 F 26-45 Benjamin Kid - 1 WM 16-26, 1 WM 45 +

James M. Kidd was listed in the 1830 Wilkes County, NC Census, the 1840 Davi Co., NC Census (could be Davidson or Davie County) and in Lincoln County, NC in 1870.

Jesse James Kid & Anner Greenwood applied for a marriage bond in Surry Co. 3 Jan 1816, Jesse Johnson was bondsman. (A-3455)

James Kidd and Polly Wilkes applied 11 Mar 1816 in Surry Co., Watson Holyfield was bondsman. (A-3456)

The following tax list is the complete listing of property owners in Surry County (at that time included present-day Yadkin County) for the year 1812. This listing of over 1,600 persons is an exact copy of the hand-written original. However, only the number of acres owned by an individual and the number of white polls listed are included here. Black Polls, town lots, the numbers of the lots, retailer listings, and the number of studs have not been included.

There are twelve separate districts, and the names are arranged alphabetically within each district, but not past the initial letter of the last or family name.
